## I. <u>BY THE COMMISSION</u>

### A. Statement

1. This matter comes before the Commission for consideration of an application (Application) filed by the Colorado Department of Transportation (CDOT) on behalf of the Town of Timnath (Timnath) on October 18, 2022, requesting authority to install active warning equipment consisting of flashing lights, four quadrant gates with timed exit gates, bells, a new cabin, constant warning time circuitry, new signal cabin, and new concrete crossing material, and detached sidewalks using Federal Section 130 Funds, at the crossing of Main Street with the tracks of the Great Western Railway of Colorado (GWR) at railroad mile post 81.24 of the Greeley Subdivision, National Inventory No. 244878F, in Timnath, County of Larimer, State of Colorado.

2. The Commission gave notice of this Application (Notice) to all interested parties, including adjacent property owners pursuant to § 40-6-108(2), C.R.S. The Notice was mailed on October 31, 2022.

3. There were no interventions in this matter.

4. The Commission has reviewed the record in this matter and deems that the Application is complete within the meaning of § 40-6-109.5, C.R.S.

5. The Commission has jurisdiction in this matter under §§ 40-4-106(2)(a) and (3)(a), C.R.S.

6. Now being fully advised in the matter, we grant the Application.

### **B.** Findings of Fact

7. The Commission gave notice to all interested parties, including the adjacent property owners. No intervention was received opposing the Application.

8. CDOT requests authority to install active warning equipment consisting of flashing lights, four quadrant gates, bells, new signal cabin, constant warning time circuitry, new concrete crossing material and detached sidewalks at the crossing of Main Street with the GWR. The four quadrant gates are proposed to be operated with timed exit gates with the proposed exit gate clearance time at 14.5 seconds.

9. There have been no accidents at the crossing since 1975.

10. CDOT states the current traffic volume using the crossing is approximately 2,700 vehicles per day (VPD) at a posted speed limit of 25 miles per hour (MPH) with approximately 4 percent heavy vehicles using the crossing. School buses do use the crossing. Traffic is projected to grow to approximately 3,000 VPD by 2026 and 4,800 VPD by 2041.

There are currently approximately 4 thru train movements per day using the crossing at speeds of up to 20 MPH with no current projections of future train traffic growth.

11. The estimated cost for the work at the crossing is \$351,724.04 for the signal work, \$4,200 for the track work, and \$100,551 for the civil engineering elements of construction. Timnath will pay \$136,151 for installation of the exit gates and sidewalks and the Federal Section 130 Funds will pay \$358,124.04 to fund the remaining construction.

12. CDOT estimates that construction will begin on March 20, 2023 and be completed by December 25, 2025. CDOT will be required to file a copy of the signed Construction and Maintenance Agreement for this crossing prior to starting work at the crossing. We will expect this signed agreement to be filed no later than March 20, 2023 prior to the start of construction. We will also require CDOT to inform the Commission in writing that the crossing work is complete and operational within ten days of completion. The Commission will expect this letter by December 31, 2024. However, the Commission does understand this letter may be provided earlier or later than this date depending on changes or delays to the construction schedule.

13. We will require CDOT and GWR to update their respective parts of the crossing inventory form for this crossing and file a copy of the updated crossing inventory form in this proceeding. The Commission will expect this information to be filed with the completion of the crossing work by December 31, 2024.

# C. Conclusions

14. The Commission has jurisdiction in this matter under §§ 40-4-106(2)(a) and (3)(a), C.R.S.

15. No intervenor that filed a petition to intervene or other pleading contests or opposes the Application.

16. Because the Application is unopposed, the Commission will determine this matter, upon the record, without a formal hearing under § 40-6-109(5), C.R.S., and Rule 1403, Commission Rules of Practice and Procedure, 4 *Code of Colorado Regulations* 723-1.

17. Based on the Findings of Fact, we find good cause exists and that the requirements of public safety are met by granting the Application consistent with the above discussion.

### II. <u>ORDER</u>

### A. The Commission Orders That:

1. The application (Application) filed by the Colorado Department of Transportation (CDOT) on behalf of the Town of behalf of the Town of Timnath (Timnath) on October 18, 2022, requesting authority to install active warning equipment consisting of flashing lights, four quadrant gates with timed exit gates, bells, a new signal cabin, constant warning time circuitry, new signal cabin, and new concrete crossing material, and detached sidewalks using Federal Section 130 Funds, at the crossing of Main Street with the tracks of the Great Western Railway of Colorado (GWR) at railroad mile post 81.24 of the Greeley Subdivision, National Inventory No. 244878F, in Timnath, County of Larimer, State of Colorado is deemed complete within the meaning of § 40-6-109.5, C.R.S.

- 2. The Application is granted.
- 3. The exit gate clearance time at this crossing is 14.5 seconds.

4. CDOT is authorized and ordered to proceed with installation of active warning equipment consisting of flashing lights, gates, bells, new signal cabin, constant warning time circuitry, new concrete crossing material, concrete, and detached sidewalks at the crossing at Main Street in Timnath.

5. CDOT shall file a copy of the signed Construction and Maintenance Agreement for this project by March 20, 2023 prior to starting work at the crossing.

6. CDOT shall inform the Commission in writing that the crossing changes are complete and operational within ten days of completion. We shall expect this letter by December 31, 2024. However, we understand this letter may be provided earlier or later than this date depending on changes or delays to the construction schedule.

7. CDOT and GWR shall be required to update the National Inventory Form for this crossing and file a copy of the updated crossing inventory form in this proceeding by December 31, 2024.

8. The 20-day period provided for in § 40-6-114, C.R.S., within which to file applications for rehearing, reargument, or reconsideration, begins on the first day following the effective date of this Decision.
