I. <u>BY THE COMMISSION</u>

A. Statement

- 1. This matter comes before the Commission for consideration of approval of one Corrective Action Plan (CAP) that was submitted by the metro Denver area Regional Transportation District light rail operation that occurred between October 1, 2022, and December 31, 2022. A report summarizing the CAP was filed by Staff of the Public Utilities Commission (Staff) on February 16, 2023.
- 2. CAP1-11222022 was approved and will be monitored to closure by Commission Decision for final approval and monitoring to closure.
- 3. This matter also comes before the Commission for consideration of fifteen CAP's that Staff has monitored and verified that all CAP elements have been completed as outlined in the CAPs and as discussed in the report summarizing the CAP's filed by Staff on February 16, 2023. The CAP numbers reviewed by Commission for closure are: CAP1-08202020, CAP1-10262020,

CAP1-11132020, CAP11-11132020, CAP3-12182020, CAP8-12182020, CAP10-01282021, CAP1-04202021, CAP1-06152021, CAP3-11112021, CAP4-12282021, CAP7-02112022, CAP9-03022022, CAP10-03022022 and CAP12-03022022.

- 4. The Commission has reviewed the summary report filed by Staff and concurs with Staff's review of the CAPs and recommendations for final approval and monitoring to closure of the one new CAP, and for closure of fifteen existing open CAPs.
- 5. The Commission has jurisdiction in this matter under § 40-18-103, C.R.S., and Rule 7347 of the Rules Regulating Railroads, Rail Fixed Guideways, Transportation by Rail, and Rail Crossings, 4 *Code of Colorado Regulations* 723-7.

II. ORDER
