I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

1. By this Decision, the Commission grants the Motion to Enlarge Time for Transcript,

filed by Towing Done Right, LLC, formerly Towing Done Right, Inc., (Towing Done Right) on March 27, 2023.

2. By prior Decision No. C23-0196-I, issued March 22, 2023, the Commission granted the first request of Towing Done Right for additional time to file the transcript and exceptions with record support in this Proceeding. After considering the motion and the grounds

stated therein, the Commission extended the deadlines for filing the transcript, any exceptions, and response time to any filed exceptions.

3. In this second motion, Towing Done Right states that additional time is needed to file the transcript, as the transcription company has provided an expected completion date of April 10, 2023. Towing Done Right maintains this brief enlargement of time would not prejudice any other party, considering the speed with which the appeal is otherwise proceeding.

4. The Commission finds good cause to take up this second motion expeditiously, since the deadlines set by prior order have or are soon expiring. We therefore waive remaining response time to the motion.

5. In this limited circumstance, where Towing Done Right has reasonably explained that the additional extension is needed to accommodate the timeline of the transcription company, through no clear fault of Towing Done Right, we find good cause to grant this second motion and modify the deadlines for filing the transcript, any exceptions, and response time to any filed exceptions. We therefore grant the motion and establish the following modified filing deadlines:
