I. <u>BY THE COMMISSION</u>

A. Statement

(Application) filed by the Colorado Department of Transportation (CDOT) on October 27, 2023, requesting authority to remove the passive warning signs and install flashing light with gates, bells, constant warning time circuitry, and new signal cabinet at the crossing of Railroad Avenue with the tracks of the Union Pacific Pailroad Company (UPPP) at railroad milenest 63.45 of the

This matter comes before the Commission for consideration of an Application

with the tracks of the Union Pacific Railroad Company (UPRR) at railroad milepost 63.45 of the

Greeley Subdivision National Inventory No. 804877W near the Town of Ault, County of Weld,

in the State of Colorado.

2. The Commission gave notice of this Application (Notice) to all interested parties

including adjacent property owners pursuant to § 40-6-108(2), C.R.S, the Notice was mailed on

October 31, 2023.

- 3. There were no interventions filed in this matter.
- 4. The Commission has reviewed the record in this matter and deems the Application complete within the meaning of § 40-6-109.5, C.R.S.
- 5. The Commission has jurisdiction in this matter under §§ 40-4-106(2)(a) and (3)(a), C.R.S.
 - 6. Now being fully advised in the matter, we grant the Application.

B. Findings of Fact

- 7. The Commission gave notice to all interested parties, including the adjacent property owners. No intervention was received opposing the Application.
- 8. CDOT seeks authority to remove the passive warning signs and installing active warning equipment including flashing light signals with gates, bells, constant warning time circuitry, and new cabinet at the crossing of Railroad Avenue in Weld County, Colorado.
- 9. CDOT is proposing changes at Railroad Avenue because there is short storage distance on the west side of the crossing due to the parallel US 85. There are also two tracks at the crossing which could create visibility issues of a second train. West side turns north and south to parallel frontage road between the tracks and US85 is obstructed by the Northern Feed and Bean Scale building on the southeast quadrant. The flashing lights and gates will provide drivers with information about an oncoming train. Advanced warning signs are also proposed to be upgraded at the crossing.
- 10. There are currently 12 trains per day that use the crossing at a maximum timetable speed of 60 MPH with no anticipated increases or decreases in the number or character of trains at this time. There are currently 68 Vehicles Per Day (VPD) with approximately five percent

heavy vehicles and school buses that do not use the crossing at an unposted statutory speed limit of 55 MPH. Vehicle volume is projected to increase to 79 VPD in five years and 90 VPD in 20 years.

- 11. There have been six accidents at the crossing since 1975 including four property damage only accidents in 2003, 2012, 2018, 2019, and two injury accidents at the crossing in 2005, and 2021. CDOT states that the cost of the active warning equipment is estimated at \$538,020. Section 130 funds will pay for the costs of this project. An estimate for ongoing maintenance was also included with the cost estimate and will be disallowed pursuant to 4 *Code of Colorado* 723-7-7301(a).
- 12. CDOT proposes to start construction on May 1, 2024, and be completed by December 31, 2025. We will require CDOT to inform us in writing that construction is complete within ten days of project completion. We shall expect this letter by December 31, 2025. However, we understand this letter may be provided earlier or later than this date depending on changes or delays to the construction schedule. We will also require CDOT to file a copy of the signed Master Agreement Task Order by April 30, 2024, prior to starting construction at the crossing.
- 13. CDOT and UPRR shall be required to update the U.S. DOT National Inventory form for this crossing and file an updated copy of the form in this proceeding by December 31, 2025.

C. Conclusions

14. The Commission has jurisdiction in this matter under §§ 40-4-106(2)(a) and (3)(a), C.R.S.

- 15. No intervenor that filed a petition to intervene or other pleading contests or opposes the Application.
- 16. Because the Application is unopposed, the Commission finds that it will determine this matter upon the record, without a formal hearing under § 40-6-109(5), C.R.S., and Rule 1403, 4 CCR 723-1 of the Rules of Practice and Procedure.
- 17. We find that good cause exists and that the requirements of public safety are met by granting the Application consistent with the above discussion.

II. ORDER

A. The Commission Orders That:

- 1. The Application (Application) filed by the Colorado Department of Transportation (CDOT) on October 27, 2023, requesting authority to remove the passive warning signs and install flashing light with gates, bells, constant warning time circuitry, and new signal cabinet at the crossing of Railroad Avenue with the tracks of the Union Pacific Railroad Company (UPRR) at railroad milepost 63.45 of the Greeley Subdivision National Inventory No. 804877W near the Town of Ault, County of Weld, State of Colorado is deemed complete.
 - 2. The Application is granted.
- 3. CDOT is authorized and ordered to remove the existing passive warning signs and install flashing lights, gates, bells, constant warning time circuitry, and new signal cabin at the crossing of Railroad Avenue with the tracks of UPRR.
- 4. CDOT shall be required to file a copy of the signed Master Agreement Task Order by April 30, 2024, prior to starting construction at the crossing.

- 5. CDOT shall inform the Commission in writing when the crossing changes are complete within ten days of completion. The Commission will expect the letter by December 31, 2025. However, the Commission understands this letter may be provided earlier or later than this date depending on changes or delays to the construction schedule.
- 6. CDOT and BNSF shall be required to update the U.S. DOT National Inventory form for this crossing and file an updated copy of the form in this proceeding by December 31, 2025.
- 7. The 20-day period provided for in § 40-6-114, C.R.S., within which to file applications for rehearing, reargument, or reconsideration, begins on the first day following the effective date of this Decision.
 - 8. The Commission retains jurisdiction to enter further decisions as necessary.

9. This Decision is effective on its Mailed Date.
