I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

1. By this Decision, the Commission grants the Unopposed Joint Motion for Partial Variance from Decision No. C23-0158-I ("Motion"), filed by Public Service Company of Colorado ("Public Service" or "the Company") on June 20, 2023. Public Service filed the Motion jointly with intervenors Trial Staff of the Colorado Public Utilities Commission; the Colorado Office of the Utility Consumer Advocate; Colorado Energy Consumers; the Colorado Energy Office;

Molson Coors Beverage Company; Federal Executive Agencies; and Walmart Inc. (with Public Service, the "Joint Movants"). The Motion requests the Commission grant a partial variance from Decision No. C23-0158-I, issued March 3, 2023, in order to make certain modifications to the procedural schedule in this Proceeding. The Motion is unopposed.

2. The Joint Movants state they have reached a nearly comprehensive settlement, with only two issues reserved for litigation. The Joint Movants state they filed in this Proceeding a Notice of Settlement and Motion to Approve Nearly Comprehensive Settlement on June 20, 2023. Given this development, they request the Commission: (a) extend the settlement deadline to June 20, 2023; (b) extend the settlement testimony deadline from June 21, 2023 until on or before June 27, 2023; and (3) vacate the July 6-7, 2023 evidentiary hearing dates. In addition, the Joint Movants state the parties to this Proceeding support scheduling a prehearing conference on one of the vacated hearing dates, should the Commission deem a conference appropriate. The Joint Movants request waiver of response time.

3. Since the Motion is unopposed, we find good cause to waive the remaining response time and take up the matter expeditiously. Upon review of the Motion, the Commission finds good cause to grant the requested relief. In addition, on its own motion, the Commission finds good cause to vacate the hearing dates scheduled for July 19 and July 21.
