I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

1. This matter comes before the Commission for consideration of a motion submitted

on August 24, 2023, by Hy-Mountain Transportation, Inc., doing business as High Mountain Taxi

(Applicant), requesting that the Commission grant a 30-day extension to comply with the terms of

Decision No. C23-0421 (Decision).

2. On April 19, 2023, Applicant filed an application for approval to consolidate

Certificate of Public Convenience and Necessity Nos. 55723 and 14114 into one certificate and to

eliminate the overlaps and/or duplications therein.

3. The Commission noticed the application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on May 8, 2023. This proceeding was

uncontested; and thus, it was determined without a hearing.

- 4. On June 26, 2023, the Commission issued the Decision and granted the application, subject to Applicant's full compliance with the requirements contained in Ordering Paragraph No. 5 of the Decision.
- 5. Ordering Paragraph No. 5 of the Decision requires Applicant to file a tariff and pay the \$5.00 issuance fee.
- 6. The Decision gave Applicant 60 days from its effective date of June 26, 2023, to comply with each of these requirements. For good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within 60 days of the effective date of the Decision.
- 7. On August 24, 2023, Applicant timely filed the instant motion for a 30-day extension to comply with the Decision. Mr. Matt Cook, the president of Applicant, states: "The reason for this request is due to an administrative error on behalf of High Mountain Taxi. Thus, we are requesting additional time to ensure Ordering Paragraph 5 is completed in a proper and thorough manner."
- 8. The Commission concludes that good cause exists to grant Applicant's request for a 30-day extension to comply with the Decision.

## II. ORDER

## **A.** The Commission Orders That:

1. The motion filed by Hy-Mountain Transportation, Inc., doing business as High Mountain Taxi, on August 24, 2023, requesting that the Commission grant a 30-day extension to complete the requirements set forth in Decision No. C23-0421, is granted.

- 2. Hy-Mountain Transportation, Inc., doing business as High Mountain Taxi, is granted 30 days from the Mailed Date of this Decision to comply with the requirements set forth in Decision No. C23-0421.
- 3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.
