I. <u>BY THE COMMISSION</u>

A. Statement, Discussion, and Findings

1. Rule 3206(d) of the Commission's Rules Regulating Electric Utilities, 4 *Code of Colorado Regulations* (CCR) 723-3, requires each Colorado electric utility to file with the Commission, no later than April 30 of each year, information on its proposed new construction or extensions of transmission facilities for the next three calendar years. Rule 3206(d)(II)(B) directs Commission staff to review the filings and comments, and to make recommendations to the Commission by July 1.

2. Through Decision No. C23-0434, issued July 6, 2023, the Commission extended the deadline for staff to make recommendations to the Commission to August 3, 2023. Through Decision No. C23-0525, the deadline for recommendations was further extended to September 27, 2023.

3. Commission Staff (Staff) filed Recommendations in this proceeding on September 27, 2023, in accordance with Decision No. C23-0525. The filing was deleted from E-Filings due to administrative difficulties, and Staff re-filed its Recommendations on September 29, 2023.

4. The Commission recognizes that in past annual Rule 3206(d) proceedings, written staff recommendations were not filed. However, in this year's proceeding, we appreciate the additional transparency that written staff recommendations provide. The Commission will take up Staff's Recommendations at a future Commissioners' Weekly Meeting, with the assistance of advisory staff as necessary. We do not anticipate that future annual Rule 3206(d) proceedings will necessarily follow this process.

5. The Commission directs that any responses to Staff's Recommendations be filed by October 19, 2023.

II. ORDER

A. It Is Ordered That:

1. Responses to the Recommendations of Commission Staff, filed on September 27, 2023, and re-filed on September 29, 2023, are due by **October 20, 2023**.
