INTERIM COMMISSION DECISION ESTABLISHING A PROCEDURAL SCHEDULE AND DISCOVERY PROVISIONS, SCHEDULING AN EVIDENTIARY HEARING, SCHEDULING A PUBLIC COMMENT HEARING, AND ESTABLISHING A DEADLINE FOR RESPONSIVE COMMENTS REGARDING HEARING VENUE

I. <u>BY THE COMMISSION</u>

A. Statement

- 1. On August 1, 2023, Public Service Company of Colorado (Public Service or Company) filed its Clean Heat Plan Application (Application), which requests that the Commission approve the Company's proposed 2024-2028 Clean Heat Plan (Clean Heat Plan).
- 2. Through this Decision, we address the Notice of Filing of Proposed Procedural Schedule (Notice) filed by Public Service on November 13, 2023. Consistent with the discussion below, we: (1) adopt the unopposed procedural schedule set forth in the Notice; (2) schedule an evidentiary hearing; (3) schedule a public comment hearing; (4) adopt the proposed discovery process; and (5) establish a deadline for responses on the evidentiary hearing venue.

В. Notice

3. By Decision No. C23-0746-I, issued November 3, 2023, we set this matter for a hearing before the Commission en banc, required the parties to confer on a procedural schedule, and directed Public Service to file a proposed procedural schedule by 5:00 p.m., on November 13, 2023.

4. On November 13, 2023, Public Service filed the Notice. The Company states that it conferred with all parties and that the following proposed procedural schedule is unopposed:2

5. Additionally, Public Service notes that the Colorado Energy Office (CEO) and the Colorado Office of Utility Consumer Advocate (UCA) recommend that the Commission schedule an additional prehearing conference on March 4, 2023. They propose that this would provide opportunity for the Commission to provide feedback to the parties or raise questions about the

record or any settlement that may have been filed. They add this would also allow the Commission to discuss any of the Commissioners' ideas or concerns regarding the case so that the parties can prepare and address those ideas during the hearing.³ The Company indicates that it opposes this idea, as does a number of other parties. The Company argues that the proposed additional prehearing conference could prejudice the due process rights of the Company and has the potential to introduce new, or materially modify, issues without a basis tied to the evidentiary record.

- 6. In the Notice, Public Service also states that discovery procedures will be governed by the Commission's existing rules.
- 7. The Company states that the parties believe a public comment hearing would be appropriate and leave it to the Commission's discretion when to hold one or more public comment hearings.

C. Findings and Conclusions Regarding Procedural Schedule and Procedures for Evidentiary Hearing and Discovery

8. The Commission appreciates the conferral efforts that resulted in an uncontested proposed procedural schedule and will adopt the proposed deadlines set forth above with a few limited exceptions. We note that the Commission actually deemed the Application complete on September 16, 2023, pursuant to Decision No. C23-0626, issued September 19, 2023. Therefore, we correct the above schedule to reflect the September 16, 2023, deem complete date as well as the anticipated date of the Commission's final decision, which is actually May 23, 2024. Further, we decline to set a deadline for statements of positions at this time. We will consider the appropriate deadline for statements of positions at or closer to the evidentiary hearing. Finally, we

find it necessary to set the settlement deadline to noon on March 1, 2024, to ensure that the Commission has adequate time to review any potential settlement.

- 9. Consistent with the unopposed procedural schedule, we schedule an *en banc* evidentiary hearing for March 11-15, 2024, and March 18-19, 2024 (if needed).
- 10. The Notice did not indicate whether it was the parties' preference that the hearing be held remotely or in person. To that end, we request conferral comments no later than three weeks from the mail date of this Decision regarding party preference on holding the hearing remotely, in-person, or in some hybrid fashion. We will, through future decision, establish hearing procedures for the evidentiary hearing once the Commission determines the hearing venue.
- 11. We accept the discovery procedures set forth in the Notice, which do not request any changes from the Commission's established rules. The discovery rules and procedures contained in Rule 1405 of the Commission's Rules of Practice and Procedure, 4 *Code of Colorado Regulations* (723-1), govern discovery in this Proceeding. We remind the parties to be judicious in their discovery requests. Parties should be mindful of the cost implications of discovery, especially where-as here-there are numerous intervenors.
- 12. Finally, we decline to set a prehearing conference as proposed by UCA and CEO at this time. We agree with the Company that following the Commission's traditional approach to hearing adjudications is preferable.

D. Findings and Conclusions Related to Scheduling a Public Comment Hearing

- 14. The Company states in the Notice that the parties believe a public comment hearing would be appropriate and leave it to the Commission's discretion when to hold one or more public comment hearings.
- 15. We find it appropriate to schedule a public comment hearing for January 8, 2024, commencing at 4:00 p.m. and continuing until 6:00 p.m., or until concluded by the Commission.
- In the public comment hearing will be held using the web-based video conferencing Zoom platform. Members of the public cannot attend the remote public comment hearing in person. Additional information about participation in the public comment hearing, such as any sign-up sheet, and all relevant information on how to log on to the remote public comment hearing will be made available on the Commission's calendar, at: https://puc.colorado.gov/puccalendar.
- 17. A court reporter will live transcribe the public comment hearing to create a written record of the comments received. Commenters should give their full name, and spell it, before they give their comments. In general, commenters will be called to speak in the order in which they sign up during the hearing. The presiding officer may adopt procedures and time limits for comments as necessary to ensure that all members of the public have opportunity to comment, and the transcribed record is clear and understandable. Typical time limits range from one to three minutes for each commenter. To ensure the hearing time is used efficiently, commenters are requested to avoid repetitive comments that re-state filed written comments or repeat oral

comments already provided at hearing. As discussed below, written public comment can be filed at any time in the proceeding and will be afforded the same weight as oral comments. Finally, the purpose of a public comment hearing is to provide opportunity for members of the public to provide oral comments. To that end, parties to the Proceeding and their representatives are not permitted to present comments. Individuals may present comments on their own behalf.

- 18. The Commission will publicize the remote public comment hearing by press release, announce it on the Commission's public calendar, and make it known by other avenues to the extent resources are available.
- 19. The remote public comment hearing will be webcast on the Commission's website. This means that those persons wishing to observe but not participate in the public comment hearing may do so by watching the webcast. To observe the public comment hearing, enter this link in the web browser https://puc.colorado.gov/webcasts. The Commission encourages interested persons who do not wish to provide comments at the remote public comment hearing to observe it through the webcast rather than joining the Zoom meeting. Doing so will help minimize background noise during the hearing and may assist in the orderly progression of the hearing.
- 20. Participating in the public comment hearing is not the only way to provide comments in this Proceeding. We encourage interested persons to provide written or oral public comments at any time this Proceeding is open. For reference, please include "Proceeding No. 23A-0392EG" in the written comments.
