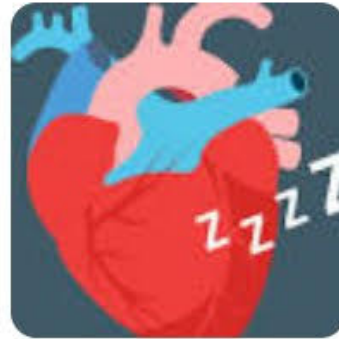
Treatment depends on the cause of the problem. **With coronary artery disease, the patient will need either a stent or coronary bypass surgery to open up the artery. If it's the valve, the patient will need a valve repair or replacement.** “All patients undergo intensive medical therapy when first diagnosed,” says Nguyen.

Can you live with damaged heart muscle? ^

You can live with coronary artery disease, but it reduces your heart's function. When heart muscle dies, scar tissue typically forms in the area. If the muscle is only dormant, however, doctors can try to restore blood flow by reopening your artery, reviving the muscle and strengthening your heart's function, Dr. Feb 8, 2019
