Re: Complaint Against Wyatt's Towing Company for Illegal Towing and Request for Refund

Dear Sir/Madam,

I am writing to file a formal complaint against Wyatt's Towing Company regarding the unlawful towing of my vehicle on August 3rd, 2023, from the parking lot of my apartment complex, located at 11735 Decatur St, Westminster, CO 80234. I am seeking appropriate action and a refund of the charges incurred to retrieve my vehicle.

On the evening of August 2nd, 2023, I purchased the aforementioned vehicle and parked it in the designated parking lot of my apartment complex at approximately 8:30 PM. To my dismay, when I woke up on August 3rd, 2023, at 6:45 AM, I discovered that my vehicle had been towed by Wyatt's Towing Company without any prior warning or notification.

According to Colorado Law, specifically HB22-1314, towing companies are required to provide a 24-hour notice before towing vehicles from apartment complex parking lots. However, I received no such notice, and as a result, I was unable to take any necessary actions, such as obtaining a parking permit from the leasing office, which is only open between 10 AM and 6 PM, Monday through Saturday.

Furthermore, I was forced to pay \$375.05 to Wyatt's Towing Company to reclaim my vehicle. The charges imposed on me were unjust and unlawful, given that the towing was carried out without adhering to the legal requirements for proper notice.

As a diligent and responsible vehicle owner, I have complied with all parking regulations and requirements set forth by my apartment complex. It is both frustrating and disheartening to be a victim of such unlawful and negligent towing practices.

I am therefore kindly requesting the Colorado Public Utilities Commission to initiate an investigation into the actions of Wyatt's Towing Company, as well as to take appropriate enforcement actions against the company for its failure to comply with Colorado's towing laws and regulations. Additionally, I seek a full refund of the \$375.05 I was unjustly charged by the towing company to retrieve my vehicle.
