MOTION, APPROVING MODIFIED PROCEDURAL  
SCHEDULE, AND VACATING AND RESCHEDULING  
EVIDENTIARY HEARING**

**I. BY THE COMMISSION**

**A. Statement**

1. On January 13, 2021, by Decision No. C21-0026-I, the Commission granted a Joint Motion to Vacate Scheduling Conference and Approve Proposed Procedural Schedule, Discovery Procedures, and Confidentiality Procedures filed by Black Hills Colorado Gas, Inc. (Black Hills or the Company), Staff of the Commission (Staff), the Office of Consumer Counsel (OCC), and Bachelor Gulch Village Association (BGVA). The Commission scheduled an evidentiary hearing for April 12-14, 2021 in accordance with the approved procedural schedule.

2. On February 19, 2021, Black Hills, Staff, the OCC, and BGVA filed a Joint Motion to Revise Procedural Schedule (Joint Motion).

3. This Decision grants the Joint Motion. The evidentiary hearing scheduled for April 12-14, 2021 is vacated and rescheduled to April 28-30, 2021. Certain other procedural deadlines are also modified, as explained below. However, the provisions for discovery and confidentiality

procedures are unchanged from those approved by Decision No. C21-0026-I. The Public Comment Hearing also remains scheduled for April 1, 2021.

**B. Discussion**

4. Black Hills, Staff, the OCC, and BGVA (collectively the Joint Movants) explain in the Joint Motion that Commission Advisory Staff requested the parties to this Proceeding confer to determine if the previously approved evidentiary hearing can be rescheduled to later dates. The Joint Movants conferred on potential new dates for the hearing and propose the following modifications to the procedural schedule established by Decision No. C21-0026-I:

5. The Joint Movants request waiver of response time to the Joint Motion, stating that because all parties to this Proceeding have joined in the Joint Motion, no party will be prejudiced by granting the motion or by waiving response time.

**C. Findings and Conclusions**

6. We appreciate the willingness of the parties to this Proceeding to rework the procedural schedule and to move the hearing dates to later in April. We find good cause to grant the Joint Motion and adopt the modified procedural dates set forth in the motion.

7. The Public Comment Hearing scheduled by Decision No. C21-0026-I will remain on April 1, 2021. Likewise, we make no changes to the discovery procedures and confidentiality procedures established by Decision No. C21-0026-I.

**II. ORDER**

**A. It Is Ordered That:**

1. The Joint Motion to Revise Procedural Schedule filed on February 19, 2021 by Black Hills Colorado Gas, Inc., Staff of the Commission, the Office of Consumer Counsel, and Bachelor Gulch Village Association (Joint Motion) is granted, consistent with the above discussion.

2. Response time to the Joint Motion is waived.

3. The modified procedural schedule proposed in the Joint Motion is approved.

4. The evidentiary hearing dates of April 12-14, 2021 as scheduled by Decision No. C21-0026-I are vacated, consistent with the above discussion.

5. The evidentiary hearing in this Proceeding is rescheduled as follows:
