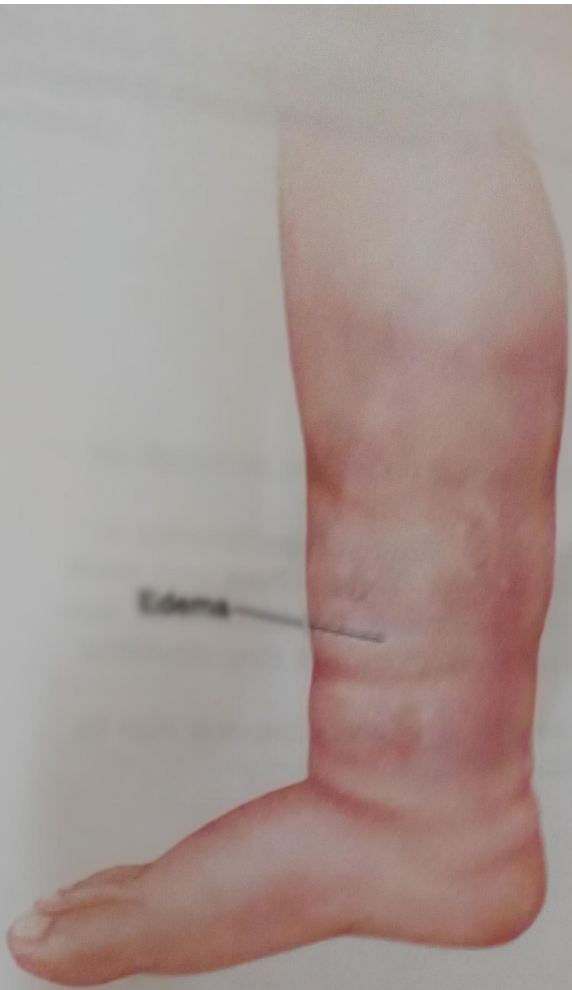

- Blood pooling in the veins of your legs (venous insufficiency) when the elasticity
- Dilated veins in your lower leg (varicose veins)
- Stockings or other clothing that is tight on your legs. This will cause bl
- Some medicines. These include some hormones such as birth control pressure medicines such as calcium channel blockers, steroids, and s such as MAO inhibitors and tricyclics.
