**I. BY THE COMMISSION**

**A. Statement, Findings, and Conclusions**

1. This matter comes before the Commission for consideration of a letter submitted on February 14, 2024, by Event and Airport Transportation LLC (Applicant), requesting that the Commission grant a 45-day extension to comply with the terms of Decision No. C23-0862 (Decision).

2. On November 8, 2023, Applicant filed an application for new permanent authority to operate as a common carrier of passengers by motor vehicle for hire.

3. The Commission noticed the application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on November 13, 2023. This proceeding was uncontested; and thus, it was determined without a hearing.

4. On December 26, 2023, the Commission issued the Decision and granted the application, subject to Applicant's full compliance with the requirements contained in Ordering Paragraph No. 3 of the Decision.

5. Ordering Paragraph No. 3 of the Decision requires Applicant to file proof of insurance; pay the motor vehicle fee and issuance fee; submit an advice letter with tariff and a vehicle inspection; and register with the Commission's electronic filing system.

6. The Decision gave Applicant 60 days from its effective date of December 26, 2023, to comply with each of these requirements. For good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within 60 days of the effective date of the Decision.

7. On February 14, 2024, Applicant timely filed the instant request for an additional 45 days to comply with the Decision. Applicant states as the reason for the request:

Two primary reasons exist for this request. One, it is currently IRS filing season for the 2023 calendar year and along with the preparation of documentation for tax filing, our administrative capacity has been overwhelmed and time constrained. Secondly, we have had an ongoing internal review, involving monitoring existing public travel and highway traffic activity between the service points in the application of the cited proceeding above, to properly justify, internal to us, the business case to provide such service. This internal review is anticipated to conclude March 15, 2024. Both of these activities have taken longer than initially anticipated to complete and are the reasons this request for additional time is needed.

8. The Commission concludes that good cause exists to grant Applicant's request for an additional 45 days to comply with the Decision.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The filing submitted by Event and Airport Transportation LLC, on February 14, 2024, requesting that the Commission grant a 45-day extension for it to complete the requirements set forth in Decision No. C23-0862, is granted.

2. Event and Airport Transportation LLC is granted 45 days from the Mailed Date of this Decision to comply with the requirements set forth in Decision No. C23-0862.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective on its Mailed Date.
