**I. STATEMENT**

**A. Procedural Background**

1. On December 1, 2023, Tri-State Generation and Transmission Association, Inc. (Tri-State) filed an Application for Approval of its 2023 Electric Resource Plan (Application).

2. On January 5, 2024, the Unopposed Motion to Intervene and Request for Hearing of La Plata Electric Association, Inc. And Mountain Parks Electric, Inc. was jointly filed by La Plata Electrical Association, Inc. and Mountain Parks Electric, Inc. (collectively, LPEA/MPE).

3. On January 5, 2024, the Joint Motion to Intervene and Entry of Appearance of Colorado Solar and Storage Association and the Solar Energy Industries Association was filed by the Colorado Solar and Storage Association and the Solar Energy Industries Association (collectively, COSSA/SEIA).

4. On January 5, 2024, the Unopposed Joint Motion to Intervene, Entry of Appearance, and Response to Motion to Approve Procedural Schedule of Moffat County and the

City of Craig, Colorado was filed by Moffat County and the City of Craig, Colorado (collectively, Moffat/Craig).

5. By Decision No. R24-0080-I, issued February 6, 2024, the undersigned Administrative Law Judge (ALJ), among other things, addressed interventions, established procedures, and provided instructions regarding exhibits.

**B. Clarification Regarding Interventions**

6. Decision No. R24-0080-I correctly states in ¶ 37 on page 10 that the requests to Intervene by LPEA/MPE, COSSA/SEIA, and Moffat/Craig will be granted. However, the Ordering section in Decision No. R24-0080-I is silent as to the granting of these intervenors’ intervention requests. Therefore, this Decision clarifies that the requests to intervene by LPEA/MPE, COSSA/SEIA, and Moffat/Craig are granted, as ordered below.

**C. Deadline for Filing of Non-Testimonial Evidence**

7. The procedural schedule adopted by Decision No. R24-0080-I does not include a deadline for the submission of non-testimonial exhibits. The ALJ finds and concludes that it is appropriate to add such deadline. Therefore, a deadline for the submission of non-testimonial exhibits will be established, as ordered below.

**D. Hearing Exhibits**

8. In Decision R24-0080-I, the ALJ instructed<sup>1</sup> the parties to use the following block numbers for hearing exhibits:

**II. ORDER**

**A. It is Ordered That:**

1. Consistent with the discussion above, the requests to Intervene by La Plata Electrical Association, Inc. and Mountain Parks Electric, Inc. (collectively, LPEA/MPE); the Colorado Solar and Storage Association and the Solar Energy Industries Association (collectively, COSSA/SEIA), and Moffat County and the City of Craig, Colorado (collectively, Moffat/Craig) are granted.

2. All parties must comply with the requirements in Attachments A and B to Decision No. R24-0080-I, which are incorporated as if fully set forth.

3. To efficiently organize exhibits that will be presented during the evidentiary hearing, all parties must use a unified numbering system for all hearing exhibits, consistent with the directions in Attachment B to Decision No. R24-0080-I, using hearing exhibits within their assigned exhibit number blocks. The parties are assigned the following hearing exhibit numbers:

4. If Tri-State Generation and Transmission Association, Inc., Staff, UCA, CEO, the Wyoming Cooperatives, the Colorado Cooperatives, the Conservation Coalition, WREA, or, WRA require more exhibit numbers than assigned, they may use the same numerical sequence of exhibit numbers assigned to them, but in the 2000 range (*e.g.*, Tri-State would use hearing exhibit numbers 2100 to 2299; Staff will use hearing exhibit numbers 2200 to 2299, *etc.*). If OJT, CIEA, CDPHE, Interwest, LPEA/MPE, COSSA/SEIA, or Moffat/Craig require more exhibit numbers than assigned, they may use the same numerical sequence of exhibit numbers assigned to them, but in the 3000 range (*e.g.*, OJT will use hearing exhibit numbers 3000 to 3099; CIEA will use hearing exhibit numbers 3100 to 3199, *etc.*).
