INTERIM DECISION OF ADMINISTRATIVE LAW JUDGE MELODY MIRBABA TAKING ADMINISTRATIVE NOTICE OF FILING AND ESTABLISHING DEADLINE FOR ADDITIONAL PUBLIC COMMENT

I. <u>STATEMENT, SUMMARY AND PROCEDURAL HISTORY</u>

A. Statement and Summary

1. This Decision takes administrative notice of a filing that the 9-1-1 Advisory Task Force (Task Force) made in Proceeding No. 17M-0276T on March 14, 2023 at 2:38 p.m. titled in the Commission's E-Filing System, "Adopted Criteria for Informal Investigations of BES Outages" (Filing Adopting Criteria); invites public comment on the same and potential changes to Rule 2143(k), 4 *Code of Colorado Regulations* (CCR) 723-2; and establishes a deadline by which such public comments must be submitted.¹

B. **Procedural History**²

- 2. During its weekly meeting held on November 29, 2023, the Colorado Public Utilities Commission (Commission) issued a Notice of Proposed Rulemaking (NOPR) to amend the Rules Regulating Telecommunications Services and Providers of Telecommunications Services contained in 4 CCR 723-2 (the Rules).³ That NOPR initiated this Proceeding and referred this matter to an Administrative Law Judge (ALJ), among other matters.⁴
- 3. Since this Proceeding was initiated, two public comment hearings have been held and members of the public have filed numerous public comments.

II. <u>DISCUSSION AND CONCLUSIONS</u>

- 4. The Commission may take administrative notice of documents in its files per Rule 1501, 4 CCR 723-1.
- 5. Among other matters, public comments raise issues relating to Commission investigations into Basic Emergency Service (BES) outages.⁵ Such investigations are performed consistent with Rule 2143(k), 4 CCR 723-2. Although the NOPR does not suggest changes to Rule 2143(k), comments include suggestions to modify that Rule.⁶
- Rule 2143(k) mandates that the Commission commence an informal investigation 6. into each apparent BES outage meeting the criteria established by the Task Force.⁷ Although the referenced criteria is not identified in the Commission's Rules, it is included in the filing that the

Task Force made on March 14, 2023 at 2:38 p.m. (Filing Adopting Criteria) in Proceeding No. 17M-0276T. The criteria are relevant to understanding suggested changes to Rule 2143(k); other proposed Rule changes; and many public comments. For example, some comments speak to the alleged burdensome nature of Commission investigations into BES outages; suggest that certain types of BES outages should not trigger an investigation; suggest changes to Rule 2143(k) to make investigations discretionary (rather than mandatory); and make other suggestions to modify the same Rule.⁸

- 7. What is more, some of CenturyLink's comments relating to proposed changes to the definitions of BES and BES outages (proposed Rule 2131(i) and (l)) require context to fully evaluate. That context includes considering the circumstances under which the Commission is required to initiate an investigation into a BES outage. For example, CenturyLink asserts that proposed changes to these definitions would require investigation into BES outages that do not involve a network failure, which would be unnecessary and an inefficient use of resources. To accurately evaluate this and related concerns, it is important to understand the circumstances under which the Commission is required to investigate a BES outage. As noted, Rule 2143(k) mandates an investigation when a BES outage meets the Task Force's criteria, which is identified in the Filing Adopting Criteria. That criteria are not otherwise included in the record in this Proceeding.
- 8. For the reasons discussed, the ALJ finds that to properly evaluate comments and suggested changes to the Rules, including changes proposed in the NOPR and comments suggesting changes to Rule 2143(k) and other Rules, it is necessary to take administrative notice of the Filing Adopting Criteria. As such, the ALJ takes administrative notice of the referenced

document, as authorized under Rule 1401(c), 4 CCR 723-1. The Filing Adopting Criteria will be contemporaneously added to the record in this Proceeding.

9. Interested members of the public are invited to submit comment relevant to the Filing Adopting Criteria by May 1, 2024, including potential changes to Rule 2143(k), 4 CCR 723-2.10

III. METHODS TO SUBMIT PUBLIC COMMENTS

- 10. Interested persons may provide written or oral comments. Although the Commission prefers written comments over oral comments, they are given the same weight.
- 11. IV. **ORDER**

It Is Ordered That: A.

1. Consistent with the above discussion, the Administrative Law Judge takes administrative notice of the 9-1-1 Advisory Task Force's March 14, 2023, 2:38 p.m. filing, titled in the Commission's E-Filing System, "Adopted Criteria for Informal Investigations of BES

Outages" in Proceeding No. 17M-0276T (Filing Adopting Criteria), which is added to the record contemporaneously herewith.
