I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

- 1. On July 31, 2025, Grand Valley Grapes and Grains Adventures LLC, doing business as Grand Valley Grapes and Grains Adventures, filed an Application seeking approval to suspend operations under its authority, Certificate of Public Convenience and Necessity ("CPCN") PUC No. 55966, from August 1, 2025, through July 31, 2026.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on August 4, 2025, for a period of 10 days.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

- 4. In accordance with Rule 6205 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* 723-6, the information submitted with this Application warrants the granting of a suspension of operations.
- 5. The Application for authority to suspend CPCN PUC No. 55966 is not contrary to the public interest and will be granted.

II. ORDER

A. The Commission Orders That:

- 1. This Application is deemed complete for purposes of § 40-6-109.5, C.R.S.
- 2. The Application filed by Grand Valley Grapes and Grains Adventures LLC, doing business as Grand Valley Grapes and Grains Adventures, for authority to suspend operations under Certificate of Public Convenience and Necessity ("CPCN") PUC No. 55966, is granted, *nunc pro tunc*, from August 1, 2025, through July 31, 2026.
 - 3. On August 1, 2026, CPCN PUC No. 55966 shall be administratively reactivated.
- 4. Prior to commencing operations, Grand Valley Grapes and Grains Adventures LLC, doing business as Grand Valley Grapes and Grains Adventures, shall: (a) cause proof of insurance or surety bond coverage to be filed with the Commission pursuant to Rule 6008, 4 *Code of Colorado Regulations* 723-6; (b) pay to the Commission the applicable vehicle identification fee for each vehicle to be operated under authority granted by the Commission; and, (c) ensure that an effective tariff is on file with the Commission, in compliance with applicable Commission rules.
- 5. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an Application for Rehearing, Reargument, or Reconsideration shall begin on the first day after the Commission mails or serves this Decision.

6. This Decision is effective immediately upon its Issued Date.
