I. BY THE COMMISSION

A. Statement

1. By this Decision, the Commission grants the Application for Rehearing, Reargument, or Reconsideration (“RRR Application”) to Decision No.C25-0680 filed by BNSF Railway Company (“BNSF”).

B. Crossing Closure Application Decision C25-0680

2. Decision C25-0680 deemed an application (“Application”) filed by BNSF on July 21, 2025, for an order authorizing it to close the crossing at County Road 15 (“CR 15”) at BNSF milepost 185.215, Kansas Division, Boise City Subdivision, National Inventory No. 003753R, in the Statutory Town of Springfield, Baca County, State of Colorado complete and granted the Application.

C. BNSF's RRR Application

3. In BNSF's RRR Application, BNSF notes that in paragraph 16 of Findings of Fact of decision C25-0680 that BNSF will be required to inform the Commission in writing that all work is complete within ten days of completion and that the Commission will expect this letter no later than October 10, 2025. BNSF also notes that paragraph 3 of the Order of decision C25-0680 orders BNSF to inform the Commission in writing that all work is complete within 10 days of completion and that the Commission will expect this letter no later than September 10, 2025. As such, BNSF respectfully requests the Commission reconsider Decision No. C25-0680 and order that BNSF will be required to inform the Commission in writing within ten days of completion and that the Commission will expect this letter no later than October 10, 2025.

D. Conclusions

4. The Commission has jurisdiction in this matter under §§ 40-4-106(2)(a) and (3)(a), C.R.S.

5. Based on BNSF's RRR Application, we find good cause exists and the Commission notes that paragraph 3 of the Order of Decision No. C25-0680 expecting a letter of completion from BNSF by September 10, 2025, is in error and the previous order is changed to expect this letter by October 10, 2025.

II. ORDER**A. The Commission Orders That:**

1. The Application for Rehearing, Reargument, and Reconsideration filed by BNSF Railway Company ("BNSF") on September 29, 2025, is granted, consistent with the discussion above.

2. The Commission notes that paragraph 3 of the Order of Decision No. C25-0680 expecting a letter of completion from BNSF by September 10, 2025, is in error and the previous order is changed to expect this letter by October 10, 2025.

3. This Decision is effective on its Issued Date.
