**INTERIM COMMISSION DECISION
ADDRESSING NOTICE PROCEDURES FOR UPCOMING
PUBLIC COMMENT HEARING**

I. BY THE COMMISSION

A. Statement, Findings, and Conclusions

1. This Proceeding addresses the Verified Application for Appeal of El Paso County's Denial of a Requisite Siting Permit ("Application") filed by Public Service Company of Colorado ("Public Service" or the "Company") on August 26, 2025. Public Service states the Application arises from denial by the El Paso County Board of County Commissioners (the "County") of a land use application that Public Service submitted to the County for approval of 45 miles of the Colorado Power Pathway Transmission Project ("Pathway Project")¹ located within El Paso County. The Application, filed under § 29-20-108(5) and § 40-4-102(1), C.R.S., requests the Commission authorize Public Service to begin construction of Segment 5 of the Pathway Project along the proposed route within the County.

¹ The Commission granted Public Service's application for a certificate of public convenience and necessity for the Pathway Project in Proceeding No. 21A-0096E by Decision No. C22-0270, issued June 2, 2022.

2. By prior Decision No. C25-0788-I, issued October 30, 2025, the Commission scheduled an in-person public comment hearing in El Paso County to be held on January 26, 2026, from 5:00 p.m. to 7:00 p.m., at Swink Hall at the El Paso County Fair and Events Center located at 366 10th Street, Calhan, CO 80808.

3. On November 3, 2025, Public Service filed a Notice of Conferral Regarding Consensus Proposal for Providing Notice of Public Hearing. Public Service proposes to notice the public comment hearing through the following means: (1) publish a legal notice in the *Colorado Springs Gazette* and (2) provide to adjacent landowners through first class mail a written notice of the public comment hearing.² Public Service indicated this proposal is unopposed although the County reserves the right to provide additional notice to potentially interested persons through its own choice of means.

4. By this Decision, the Commission finds the notice methods proposed by Public Service to be reasonable and appropriate and therefore specifies, as required by Rule 3705(g), 4 *Code of Colorado Regulations* 723-3, that Public Service shall provide notice of the public comment hearing scheduled for January 26, 2026, consistent with this proposal. The substance of the notice shall, at minimum, provide the date, location, and time of the public comment hearing, and include information specifying how to file with the Commission written comments regarding the Application. The notice specified by this Decision shall be completed no later than two weeks before the date of the public comment hearing.

5. In addition, we encourage the County to provide notice of the public comment hearing to potentially interested persons including local organizations and entities.

² Adjacent landowners are those property owners within 1,320 feet, or one-quarter of a mile, of the route to be traversed by the Pathway Project transmission line within El Paso County.

6. As a reminder to members of the public, speaking at the public comment hearing is not the only way that interested persons can provide comment. Written or oral public comments can be provided by members of the public at any time using the methods outlined below. Please include “Proceeding No. 25A-0355E” to ensure the comments are included in the administrative record of this case.

II. ORDER

A. It Is Ordered That:

1. Public Service Company of Colorado shall provide notice of the public comment hearing to be held in El Paso County, Colorado on January 26, 2026, in the manner described above. Such notice shall be completed no later than two weeks prior to the date of the public comment hearing.

2. This Decision is effective immediately upon its Issued Date.
