I. STATEMENT

- 1. This proceeding concerns Civil Penalty Assessment Notice ("CPAN") No. 139529 issued by Commission Staff ("Staff") on May 5, 2025, against Respondent Tow-Pros LLC ("Respondent" or "Tow-Pros"). The violations are specifically listed in the CPAN.
 - 2. The CPAN does not indicate how it was served.
- 3. On July 16, 2025, the Commission referred this proceeding to an Administrative Law Judge by minute entry.
- 4. On July 28, 2025, by Decision No. R25-0554-I, a prehearing conference was scheduled for August 19, 2025.

- 5. On July 31, 2025, Trial Staff of the Commission ("Staff") filed its Notice of Intervention as of Right and Entry of Appearance in this proceeding.
- 6. On August 5, 2025, Staff filed its Motion to Vacate and Reschedule Prehearing Conference and Waive or Shorten Response Time ("Motion").

II. MOTION TO VACATE AND RESCHEDULE

- 7. In their Motion, Staff states that due to scheduling conflicts they are not available for the prehearing conference scheduled on August 19, 2025. Staff requests the prehearing conference be vacated and propose it be rescheduled for August 28, 2025.
- 8. Staff also request that response time to the Motion be waived or shortened due to the short amount of time until the prehearing conference is scheduled.
- 9. Staff states it has contacted the Respondent, but the Respondent did not state a position on the Motion.

III. DISCUSSION

- 10. The undersigned ALJ finds good cause to waive response time and grant the Motion.
- 11. The Commission's calendar is full on the proposed date of August 28, 2025, therefore, the prehearing conference in this matter shall be rescheduled for September 11, 2025.
- 12. The ALJ will deem any party's failure to appear at the prehearing conference to be a waiver of any objection to the rulings made during the prehearing conference.
