**INTERIM DECISION VACATING AUGUST 28, 2025
HEARING AND RESETTING HEARING
TO OCTOBER 23, 2025**

Issued Date: August 27, 2025

I. STATEMENT

1. On April 25, 2025, Roman Lysenko (“Complainant”) initiated this matter by filing a Complaint with the Public Utilities Commission (“PUC” or “Commission”) against DTR Operations, LLC doing business as Rocky Mountain Event Shuttles (“Respondent”).

2. On August 6, 2025, by Decision No. R25-0569-I, and after conferring with the parties, the Administrative Law Judge (“ALJ”) set this Proceeding for a remote hearing date of August 28, 2025.

3. On August 26, 2025, Respondent filed a Motion to Vacate and Request for Leave to File Motion to Compel Discovery Responses and to Compel Further Responses (“Motion”).

4. On August 26, 2025, Complainant filed an Opposition to Respondent's Motion to Vacate Hearing and Request for Leave to File Motion to Compel.

5. On August 27, 2025, Respondent filed a Reply in Support of Motion to Vacate Hearing and Request for Leave to File Motion to Compel Discovery Responses and to Compel Further Responses ("Reply") with exhibits. Respondent did not include a required motion for leave to file the Reply.¹ Therefore, the ALJ will not consider the Reply and will strike it from the record.

6. Based on the filings, the ALJ will vacate the scheduled hearing and continue it to October 23, 2025 at 9:00 a.m.

7. The remainder of Respondent's requested relief in the Motion will be addressed by a separate decision.

II. ORDER

A. It Is Ordered That:

1. Respondent DTR Operations, LLC doing business as Rocky Mountain Event Shuttles' ("Respondent") August 27, 2025 Reply in Support of its Motion to Vacate Hearing and Request for Leave to File Discovery Motion to Compel Discovery Responses and to Compel Further Responses as Necessary is stricken from the record in this Proceeding.

2. The August 28, 2025 hearing in this Proceeding is vacated.

3. The evidentiary hearing in this Proceeding is rescheduled as follows:

DATE: October 23, 2025

TIME: 9:00 a.m.

PLACE: Join by videoconference using Zoom

4. Nobody should attend the hearing in person at the Commission's offices.

5. Participants in the hearing may not distribute the hearing link, access, or ID code to anyone not participating in the hearing. Participants may not appear in person at the Commission for the above-scheduled hearing. Instead, they must participate in the hearing from remote locations, consistent with the requirements of this Decision.

6. All participants must comply with the requirements in Attachments A and B to this Decision, which is incorporated into this Decision.

8. Respondent must advise Daniel Siegel and Hunter Bell (both of whom were served subpoenas to testify at hearing) that the August 28, 2025 hearing is vacated. In addition, Respondent must advise Daniel Siegel and Hunter Bell of the new hearing date in a timely manner.

7. Complainant Roman Lysenko must advise Heather Rahder and Luis Negrón (both of whom were served subpoenas to testify at hearing on behalf of ACE Express Coaches, LLC), that the August 28, 2025 hearing is vacated. In addition, Complainant must advise Heather Rahder and Luis Negrón of the new hearing date in a timely manner.

8. This Decision is effective immediately.
