## INTERIM DECISION SCHEDULING EVIDENTIARY HEARING

## I. <u>STATEMENT</u>

## A. Background

- 1. On May 19, 2025, Emerald Express Transportation Inc. ("Emerald Express") filed the application described in the caption above ("Application").
- 2. On May 23, 2025, Emerald Express filed: (a) an amendment to the Application that revised the description of the geographic scope of the authority sought ("Amendment"); and (b) Application for Temporary Authority for the same geographic scope of authority sought in the Amendment. The Application for Temporary Authority was a duplicate of the same application filed in Proceeding No. 25A-0197CP-TA, which the Commission denied in Decision No. C25-0456 on June 16, 2025.
- 3. On May 27, 2025, the Commission issued public notice of the authority sought by Emerald Express in the Application as follows:

For permanent authority to operate as a common carrier by motor vehicle for hire for the transportation of passengers as follows:

- (1) Transportation of passengers in call-and-demand shuttle service between all points within the city of Steamboat Springs, Colorado, and between said points, on the one hand, and the Yampa Valley Regional Airport, Hayden, Colorado, on the other hand.
- (2) Transportation of passengers in call-and-demand shuttle service between all points within the city of Craig, Colorado, and between said points, on the one hand, and the Yampa Valley Regional Airport, Hayden, Colorado, on the other hand.
- 4. On June 11, 2025, Alpine Taxi/Limo, Inc. ("Alpine Taxi") filed a Notice of Intervention by Right, Alternative Motion for Intervention, Entry of Appearance, and Request for Hearing.
- 5. On June 17, 2025, NDW Enterprises LLC d/b/a Ski Town Transportation ("Ski Town Transportation") filed an Intervention by Right to Permanent Authority Application.
- 6. On July 9, 2025, the Commission deemed the Application complete and referred the proceeding by minute entry to an Administrative Law Judge ("ALJ"). The proceeding was subsequently assigned to the undersigned ALJ.
- 7. On July 23, 2025, the ALJ issued Decision No. R25-0540-I that established a procedural schedule, and a deadline of August 1, 2025 for any Statements to be filed in which the filing party could specify the party's preference for an in-person, remote, or hybrid hearing and, if the party prefers an in-person hearing, identification of the preferred location for the hearing and an explanation of why the hearing should not take place in one of the Commission's hearing rooms in Denver.
- 8. On August 1, 2025, each party filed a Statement Regarding Hearing. All parties prefer an in-person hearing in Steamboat Springs (Emerald Express changed its preference from that expressed in its Application for a hearing in Denver). Alpine Taxi stated that "some potential

witnesses are not from Steamboat" and requested that those witnesses be permitted to appear

remotely at the hearing in Steamboat Springs over the Zoom webconferencing platform.

**B.** Hearing and Remote Prehearing Conference

9. The evidentiary hearing will be scheduled for September 30 to October 1, 2025 in

Steamboat Springs. The hearing will be conducted as an in-person hearing. However, the ALJ

reserves the right to change the hearing to a hybrid hearing if the internet connection at the

hearing site is sufficient and one or more witnesses cannot attend the hearing in-person. To aid

with that decision, each party must identify on its witness list each witness who the party will

call at the hearing, each witness who it may call, and whether each witness needs or wants to

testify remotely and has committed to testifying at the hearing.

10. In addition, a remote prehearing conference will be scheduled for September 25,

2025 at 3:00 p.m. All parties must appear at the remote prehearing conference. Failure to attend

or to participate in the remote prehearing conference is a waiver of any objection to the rulings

made during the remote prehearing conference. Attachment A to this Decision provides the

information addressing how to use the Zoom platform for remotely participating in the remote

prehearing conference.
