INTERIM DECISION RESCHEDULING HEARING AND CONVERTING HYBRID HEARING TO REMOTE HEARING

Issued Date: October 3, 2025

I. STATEMENT

A. Procedural Background

- 1. On June 6, 2025, Yampa Valley Transportation LLC ("Yampa" or "Applicant") initiated this matter by filing an Application for Permanent Authority to Operate as a Common Carrier by Motor Vehicle for Hire ("Application").
- 2. On June 9, 2025 Applicant filed a requested amendment for the authority it seeks in the Application.
- 3. On June 16, 2025, the Commission provided public notice under § 40-6-108(2), C.R.S., of the Application.
- 4. On July 14, 2025, NDW Enterprises LLC, doing business as Ski Town Transportation ("Intervenor" or "Ski Town") timely filed its Intervention by Right to Permanent Authority Application ("Ski Town's Intervention"), opposing the Application.
- 5. On July 23, 2025, the Commission deemed the Application complete and referred the matter to an Administrative Law Judge ("ALJ") by minute entry.

6. By Decision No. R25-0559-I, issued July 30, 2025, the undersigned ALJ, among other things, scheduled an evidentiary hearing in this Proceeding for November 4, 2025.

II. DISCUSSION, FINDINGS, AND CONCLUSIONS

Incorrect Caption in Decision No. R25-0559-I Α.

7. Decision No. R25-0559-I, issued July 30, 2025 bore an incorrect caption. This Decision bears the correct caption for this Proceeding.²

В. Rescheduling of Hearing Date and Changing of Hearing Format

- 8. Due to the ALJ's hearing schedule, the evidentiary hearing in this Proceeding must be rescheduled.
- 9. Through informal email correspondence, the undersigned ALJ inquired with the parties regarding potential new hearing dates. Intervenor's counsel responded that, after consulting with his client, November 13, 2025, works best for Intervenor. Counsel further expressed his understanding that the hearing would remain virtual and remote. As of the time of the issuance of this Decision, Applicant did not respond to the undersigned ALJ's inquiry concerning the proposed rescheduled hearing date or the hearing format.
- 10. Based on the foregoing, the ALJ finds and concludes that it is appropriate to reschedule the evidentiary hearing in this Proceeding to November 13, 2025 and change the format of the hearing from hybrid to fully remote. Therefore, the hearing scheduled for November 4, 2025, will be vacated, and a fully-remote evidentiary hearing will be rescheduled for November 13, 2025, as ordered below.
