Statutory Duties of the Committee

Section 12-7-104.5 (1)(a), C.R.S. requires the members to render advisory decisions to the Division in matters involving complaints and help to ensure that bail bonding agents properly report and pay premium tax.

Section 12-7-104.5 (1)(b), C.R.S. sets forth that the committee shall also review all rules regarding the regulation of bail bonding agents that are proposed by the Commissioner and make recommendations to the Commissioner regarding the implementation of such rules. The Commissioner shall consider the recommendation of the committee and make the recommendations public and available for review.
