ADOPTING PROCEDURAL SCHEDULE, SCHEDULING A
REMOTE EVIDENTIARY HEARING, EXTENDING TIME
FOR DECISION, AND VACATING PREHEARING
CONFERENCE.

- 1. On July 27, I issued a Decision asking the parties to confer and propose revised dates for an evidentiary hearing in this Proceeding as well as suggest whether the evidentiary hearing should be in person, hybrid, or remote. Public Service Company of Colorado, on behalf of the Parties to this Proceeding (and Black Hills Energy, participating as *amicus curiae*), filed the Joint Proposal on August 2. The Parties agree that the evidentiary hearing should be remote and propose two sets of dates for the hearing.
- 2. Given the Parties' unanimous preference, we will hold a remote evidentiary hearing in this proceeding.
- 3. After examining the Commission's calendar, I conclude that the second set of dates proposed, December 5-9, 2022, is preferable.
  - 4. Therefore, I adopt the following schedule.

- 5. Given that the procedural schedule proposed by the parties and adopted in this Decision extends beyond 120 days from the date this application was deemed complete, I find it necessary to extend the time for decision by an additional 130 days pursuant to § 40-6-109.5(1), C.R.S.
- Closer to the date of the hearing I will issue another decision establishing hearing procedures.
- 7. Finally, having settled the outstanding procedural questions it is unnecessary to hold the prehearing conference set for August 12, 2022, at 10:00 a.m. The remote prehearing conference is vacated.

## I. ORDER

#### A. It Is Ordered That:

- 1. The procedural schedule outlined above is adopted in this Proceeding.
- 2. To accommodate the approved procedural schedule, I have extended the deadline for a decision by an additional 130 days, consistent with § 40-6-109.5(1), C.R.S.
  - 3. A remote evidentiary hearing in this proceeding is scheduled as follows:
