**I. BY THE COMMISSION**

**A. Statement, Findings, and Conclusions**

1. On October 27, 2022, Alpine Taxi/Limo Inc, doing business as Alpine and/or GO Alpine and/or Steamboat Express, LLC (Steamboat Express), filed an application requesting that the Commission approve the suspension of taxi service operations authorized under Items I, II, III, and IV of Certificate of Public Convenience and Necessity (CPCN) PUC No. 26246.

2. By Decision No. C22-0751, mailed on November 28, 2022, the Commission granted the unopposed application for a partial suspension of taxi operations from November 10, 2022, through November 9, 2023.

3. On June 28, 2023, Steamboat Express submitted a “Motion Letter” requesting that the taxi authority under CPCN No. 26246 be reinstated effective July 21, 2023. The letter states: “Steamboat Express still has many requests for taxi service and wants to meet the demand for

service in the area. Steamboat Express is deploying new technology to better serve the passenger and the company for efficiency.”

4. The Commission finds good cause to grant the motion and lift the suspension of taxi services under CPCN PUC No. 26246.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The motion filed on June 28, 2023, by Alpine Taxi/Limo Inc, doing business as Alpine and/or GO Alpine and/or Steamboat Express, LLC, requesting to reinstate the taxi service authority under Certificate of Public Convenience and Necessity (CPCN) PUC No. 26246, is granted.

2. The suspension of the taxi service authorized in Items I, II, III, and IV of CPCN PUC No. 26246 is lifted as of July 21, 2023, consistent with the discussion above.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective on its Mailed Date.
