I. BY THE COMMISSION

A. Statement

- 1. This matter comes before the Commission for consideration of approval of five new Corrective Action Plans (CAPs) that were submitted by the Metro Denver area Regional Transportation District (RTD) light rail operation that occurred between April 1, 2023, and June 30, 2023. A report summarizing the CAPs was filed by Staff of the Public Utilities Commission (Staff) on October 24, 2023.
- 2. The five new CAPs are,: CAP1-04062923, CAP1-06082023, CAP1-06272023, CAP01-05042023 and CAP02-05042023. These have been reviewed by the Commission for final approval and monitoring to closure.
- 3. This matter also comes before the Commission for consideration of 12 CAPs that Staff has monitored and verified that all CAP elements have been completed as outlined in the CAPs and as discussed in the report summarizing the CAPs filed by Staff on October 24, 2023.

The CAP numbers reviewed by Commission for closure are: CAP01-08052022, CAP01-09262022, CAP01-04052022, CAP01-02152022, CAP01-12182020, CAP04-12182020, CAP05-12182020, CAP02-10122020, CAP03-11132020, CAP10-11132020, CAP01-01282021 & CAP04-0128201. These CAPS were reviewed for closure with RTD on July 19, 2023.

- 4. The Commission has reviewed the summary report filed by Staff and concurs with Staff's review of these CAPs and recommendations for final approval and monitoring to closure of these five new CAPs and for the closure of 12 existing open CAPs.
- 5. The Commission has jurisdiction in this matter under § 40-18-103, C.R.S., and Rule 7347 of the Rules Regulating Railroads, Rail Fixed Guideways, Transportation by Rail, and Rail Crossings, 4 *Code of Colorado Regulations* (CCR) 723-7.

II. ORDER

A. The Commission Orders That:

The Commission provides final approval of and monitoring to closure of CAP1-04062923, CAP1-06082023, CAP1-06272023, CAP01-05042023 and CAP02-05042023. submitted by the Metro Denver area Regional Transportation District (RTD) light rail operation, and closure of CAP01-08052022, CAP01-09262022, CAP01-04052022, CAP01-02152022, CAP01-12182020, CAP04-12182020, CAP05-12182020, CAP02-10122020, CAP03-11132020, CAP10-11132020, CAP01-01282021 & CAP04-01282021.
