I. BY THE COMMISSION

A. Statement

1. This Decision addresses a request for Relinquishment of Eligible Telecommunication Carrier (ETC) designation filed on February 23, 2024, by Starlink Services, LLC (Starlink). We approve the relinquishment of the ETC designation with further details below.

B. Background

2. The procedural history of Starlink's ETC designation is set forth in this docket by Decision No. C21-0262.

3. Starlink Applied for ETC designation as a requirement of winning bids in the Federal Communications Commission (FCC) Rural Digital Opportunity Fund (RDOF). Starlink

noted in its initial application that it applied for this designation exclusively in connection with RDOF funding.

4. Starlink notes that the Wireline Competition Bureau (Bureau) denied Starlink Services' RDOF "Long Form" application¹. Starlink subsequently appealed the Bureau decision to the FCC², and the FCC later affirmed the Bureau's decision.³

5. As indicated in Starlink's filing, Starlink will not receive any RDOF support to provide services in Colorado. Starlink has no existing subscribers and has never received universal services support, nor has it provided telecom services in the state of Colorado. For these reasons, we find granting Starlink's request to relinquish ETC designation in Colorado is in public interest and will have no adverse effects as it never provided ETC services in Colorado. We also find good cause to waive the requirement in Commission Rule 2188 that an application be filed to relinquish ETC designation; given that Starlink's ETC designation was granted in connection with RDOF funding and Starlink has not provided service under that designation we consider the February 23, 2024 Notice to be sufficient for the purposes of notice and our review.

II. ORDER

A. The Commission Orders That:

1. The request for relinquishment of its Eligible Telecommunications Carrier designation granted by Decision No. C21-0262 as presented in the February 23, 2024 Notice filed by Starlink Services, LLC is granted.
