**I. BY THE COMMISSION:**

**A. Statement, Findings, and Conclusion:**

1. On May 12, 2003, Tours 2 Go LLC, doing business as Tours 2 Go, filed an application for authority for a Certificate of Public Convenience and Necessity to operate as a common carrier by motor vehicle for hire for the transportation of passengers and their baggage in sightseeing service between all points in the Counties of El Paso and Teller, the portion of Park County either within 10 miles of the Park/Teller County Boundary or within 30 miles of the Park/Fremont County Boundary, and the portion of Fremont County lying east of a line drawn from a point on the Park/Fremont County Boundary, said point located 5 miles west of the intersection of the Teller/Fremont County Boundary, to a point on the Fremont/Custer County Boundary, said point located 30 miles west of the southeast corner of Fremont County. This application was restricted against providing service to any point on the Pikes Peak Toll Road.

2. The Commission gave notice of the application on May 19, 2003. RDS Transportation, Ltd. Yellow Cab Company of Colorado Springs &/or Greater Colorado Springs

Transportation Company &/or RDSM Transportation, Ltd., filed an intervention opposing a grant of the application.

3. The Commission received a letter on June 2, 2003, from the applicant, Tours 2 Go LLC, doing business as Tours 2 Go. In its letter, Tours 2 Go LLC, doing business as Tours 2 Go states “Please withdraw the above application for a certificate to operate as a common carrier effective immediately.” There being nothing further for the commission to consider, the request will be granted.

**II. ORDER**

**A. The Commission Orders That:**

1. This application is dismissed.
  
2. The intervention filed by RDS Transportation, Ltd. Yellow Cab Company of Colorado Springs &/or Greater Colorado Springs Transportation Company &/or RDSM Transportation, Ltd., is moot and it is therefore denied.
  
3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Order is effective on its Mailed Date.
