**I. BY THE COMMISSION**

**A. Statement**

1. This matter comes before the Commission for consideration of approval of twenty-four new Corrective Action Plans (CAPs) that were submitted by the metro Denver area Regional Transportation District light rail operation that occurred between October 1, 2020 and December 31, 2020. A report summarizing the CAPs was filed by Staff of the Public Utilities Commission (Staff) on March 4, 2021.

2. The CAP numbers reviewed by the Commission for final approval and monitoring to closure are:

3. This matter also comes before the Commission for consideration of one CAP that Staff has monitored and verified that all CAP elements have been completed as outlined in the CAP and as discussed in the report summarizing the CAPs filed by Staff on March 4, 2021.

4. The CAP number reviewed by the Commission for closure is: CAP1-12122019.

5. The Commission has reviewed the summary report filed by Staff and concurs with Staff's review of the CAPs and recommendations for final approval and monitoring to closure of the twenty-four new CAPs and for closure of one existing open CAP.

6. The Commission has jurisdiction in this matter under § 40-18-103, C.R.S., and Rule 7347 of the Rules Regulating Railroads, Rail Fixed Guideways, Transportation by Rail, and Rail Crossings, 4 *Code of Colorado Regulations* 723-7.
