STATEMENT, FINDINGS, AND CONCLUSIONS

BY THE COMMISSION:

1. On November 21, 1991, Black Hawk Central City Ace Express, Inc. filed Docket No. 91A-778CP-Extension for emergency and temporary authority to extend operations under PUC No. 47967 for the transportation of passengers between Central City and Black Hawk.

2. An intervention opposing the emergency application was timely filed on November 1, 1991, by Central City/Black Hawk Stage Lines, Inc. (CCBH). A petition to intervene was untimely filed against the temporary application by CCBH.

3. On December 18, 1991, the Applicant sent a letter to the

Commission withdrawing the emergency temporary application. On January 7, 1992, the applicant requested dismissal of the temporary application. There being nothing further for the Commission to consider, the requests will be granted.

THEREFORE THE COMMISSION ORDERS THAT:

1. These applications are dismissed.
2. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this decision.
3. This Order is effective on its date of mailing.
