**ERRATA NOTICE**

On September 23, 1992, the Commission mailed Decision No. C92-1151 which granted the Henderson Heavy Haul Trucking, Inc. application for temporary authority to extend operations under Certificate of Public Convenience and Necessity PUC No. 49688. The Applicant's attorney contacted the Commission after the Decision was mailed, and stated that Appendix A has inadvertently deleted two restrictions which were imposed on the application by stipulated motion filed September 21, 1992, between the Applicant, on the one hand, and Bob's Auto Service, Inc., and Titan Trucking, Inc., on the other hand. Accordingly, Appendix A to Decision No. C92-1151, Restrictions, is modified as follows:

RESTRICTIONS:

This certificate is restricted as follows:

- 1) against the transportation of Mercer description items;
- 2) to the use of low-boy and/or step-deck trailers;
- 3) against the transportation of shipments weighing 50,000 pounds or less within the area comprised of the Counties of Denver, Adams, Arapahoe, Jefferson, Boulder and Weld, State of Colorado; and

4) against the transportation of shipments weighing 40,000 pounds or less between points in Denver, Adams, Arapahoe, Boulder, Jefferson and Weld Counties, State of Colorado, on the one hand, and, on the other hand, points in the State of Colorado.
