COMMISSION ORDER GRANTING
TEMPORARY AUTHORITY

I. BY THE COMMISSION:

A. Statement

1. On October 25, 1995, Robert M. Regulski, 28485 Highways 6 & 24, Rifle, CO 81650, Harvey A. Gilmore, 330 Seventh Street, Glenwood Springs, CO 81602, Phillip L. Sullivan, 1540 Monaco Parkway, Denver, CO 80220, and Airport Shuttle Colorado, Inc., 330 Seventh Street, Glenwood Springs, CO 81601, filed a joint application

(Docket No. 95A-508CP-Stock Transfer-TA) for temporary approval to transfer operational control of Aspen Limousine Service, Inc., doing business as Vans to Vail, Inc. ("ALS"), record owner of Certificates of Public Convenience and Necessity Puc Nos. 14912 and 16261, to Airport Shuttle Colorado, Inc., pending the Commission's consideration of the related application for permanent stock transfer approval.

2. By § 40-6-120, C.R.S., the application for temporary approval is under consideration for a Commission order.

3. The verified statement submitted in support of this application indicates that failure to grant the application could result in injury to the certificates and ultimately effect service to the public. The Commission will, therefore, grant the application.

4. The Applicant has adequate equipment and financial resources to begin immediate service within the scope of the authority to be operated, and is willing, ready, and able to operate under all Commission rules and regulations governing carriers by motor vehicle.

5. The Transferee is fit, willing, and able to perform the operations required by Certificates of Public Convenience and

Necessity PUC Nos. 14912 and 16261.

6.This application for temporary approval is in the public interest and should be granted.

7.The Applicant is advised that the granting of a temporary approval makes no presumption that permanent approval will be granted.

II. ORDER

A.The Commission Orders That:

1.Airport Shuttle Colorado, Inc., 330 Seventh Street, Glenwood Springs, CO 81601 is granted temporary approval to assume operational control of Aspen Limousine Service, Inc., doing business as Vans to Vail, Inc., P. O. Box 1368 Glenwood Springs, CO 81602, record owner of Certificates of Public Convenience and Necessity Puc Nos. 14912 and 16261. The temporary approval shall be valid for a period of 180 days, commencing from the Mailed Date of this Order.

2.Airport Shuttle Colorado, Inc., shall not commence operations until all requirements have been met and notice in writing has been received from the Commission that it is in compliance and may begin service.

3.The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after

the Commission mails or serves this Decision.
B. This Order is effective on its Mailed Date.
