**COMMISSION ORDER
GRANTING EXTENSION OF
PERMANENT AUTHORITY**

Mailed date: December 2, 1996
Adopted date: November 27, 1996

I. BY THE COMMISSION:

Statement, Findings and Conclusion:

1. On June 1, 1996, Colorado HB 96-1114 was signed into law, and became effective on July 1, 1996. Several provisions of HB 96-1114 directly affect certificates of public convenience and necessity issued by this Commission and held by taxicab companies throughout the State of Colorado. Specifically, § 40-10-105 (2) (d),

C.R.S., was added and provides:

- (I) The holder of a certificate of public convenience and necessity that contains authority to operate as a taxicab between points in the City and County of Denver shall also be deemed to hold taxicab authority from points in the City and County of Denver to all points in the State of Colorado.
- (II) The holder of a certificate of public convenience and necessity that contains authority to operate as a taxicab to points in the City and County of Denver shall also be deemed to hold taxicab authority from points in the City and County of Denver to all points within the motor carrier's

base area, defined as that geographic area in which such carrier may provide point-to-point taxicab service.

(III) The Commission shall forthwith amend, by order and without notice or hearing, any existing taxicab certificate as described in subparagraph (I) or (II) of this paragraph (d) to allow service from points in the City and County of Denver to either all points in the State of Colorado or all points within the motor carrier's base area to conform with the directives contained in said subparagraph (I) or (II).

2. Pursuant to the provisions of § 40-10-105(2) (d), C.R.S., Certificate of Public Convenience and Necessity PUC No. 150&I held by Boulder Taxi, LLC, doing business as Boulder Yellow Cab, shall be extended, as set forth in the attached Appendix.

II. ORDER

A. The Commission Orders That:

1. Consistent with the above discussion, Certificate of Public Convenience and Necessity PUC No. 150&I is amended to conform to the requirements of HB 96-1114.

2. The complete authority under Certificate of Public Convenience and Necessity PUC No. 150&I, as amended, shall be as set forth in the attached Appendix, and this Order is a CERTIFICATE therefor.

3. Applicant shall file a proper tariff. Extended operations may not begin until this requirement has been met.

B. This Order is effective on its Mailed Date.

- 4.Glacier Lake;
- 5.Rainbow Lakes; and
- 6.Peaceful Valley;

- s.Points within a 5-mile radius of Arapaho Glacier, in the Roosevelt National Forest;
- t.Fourmile Canyon, west of Boulder, Colorado;
- u.Nederland Dam, near Nederland, Colorado;
- v.Apex and the Georgetown Loop, near Georgetown, Colorado; and
- w.Grand Lake, in the Arapahoe National Forest.

This Certificate is restricted as follows:

Item (I) is restricted as follows:

- A.All transportation shall originate or terminate in the City of Boulder, Colorado; and
- B.No service shall be performed to or from: (1) Rocky Mountain National Park; (2) Grand Lake; (3) points south of Grand Lake on U.S. Highway 40 between Granby and Denver; or (4) points south of U.S. Highway 40 between Granby and Denver, Colorado.

Item (II) is restricted as follows:

Restricted to the use of not more than 23 vehicles.
