**I. BY THE COMMISSION**

**A. Statement**

1. This matter comes before the Commission for consideration of formal adoption of 18 investigation reports submitted by the metro Denver area Regional Transportation District light rail operation. The investigation reports are for 18 accidents between the dates of January 1, 2019 and March 31, 2019. A report summarizing these accidents was filed by Staff of the Public Utilities Commission (Staff) on October 16, 2019.

2. The accident numbers for the 18 accidents reviewed by the Commission are:

3. The Commission has reviewed the summary report filed by Staff and concurs with Staff's review of the investigation reports and recommendations.

4. The Commission has jurisdiction in this matter under § 40-18-103, C.R.S., and Rule 7349 of the Rules Regulating Railroads, Rail Fixed Guideways, Transportation by Rail, and Rail Crossings, 4 *Code of Colorado Regulations* 723-7.

**II. ORDER**
