**I. BY THE COMMISSION**

**A. Statement**

1. This matter comes before the Commission for consideration of approval of five new Corrective Action Plans (CAP) that were submitted by the metro Denver area Regional Transportation District light rail operation that occurred between January 1, 2023, and March 31, 2023. A report summarizing the CAP was filed by Staff of the Public Utilities Commission (Staff) on July 2023.

2. The three new CAPs, CAP03-09212022, CAP02-11222022, and CAP01-03112023 have been reviewed and approved directly by the Commission in investigatory proceedings. The CAP numbers reviewed by the Commission are CAP01-03022023 and CAP01-03202023 for final approval and monitoring to closure.

3. This matter also comes before the Commission for consideration of seven CAPs that Staff has monitored and verified that all CAP elements have been completed as outlined in the CAPs and as discussed in the report summarizing the CAPs filed by Staff on July 19, 2023.

The CAP numbers reviewed by Commission for closure are CAP4-11132020, CAP5-11132020, CAP9-12182020, CAP8-02112022, CAP11-03022022, CAP1-07272022, and CAP1-11222022 (23I-0047R).

4. The Commission has reviewed the summary report filed by Staff and concurs with Staff's review of these CAPs and recommendations for final approval and monitoring to closure of these two new CAPs and for the closure of seven existing open CAPs.

5. The Commission has jurisdiction in this matter under § 40-18-103, C.R.S., and Rule 7347 of the Rules Regulating Railroads, Rail Fixed Guideways, Transportation by Rail, and Rail Crossings, *4 Code of Colorado Regulations 723-7*.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The Commission provides final approval of and monitoring to closure of CAP01-03022023 and CAP01-03202023 submitted by the metro Denver area Regional Transportation District light rail operations, and closure of CAP4-11132020, CAP5-11132020, CAP9-12182020, CAP8-02112022, CAP11-03022022, CAP1-07272022, and CAP1-11222022 (23I-0047R).

2. This Decision is effective on its Mailed Date.
