I. BY THE COMMISSION

A. Statement, Findings, and Conclusions

1. This matter comes before the Commission for consideration of a filing submitted on May 19, 2023, by AES Enterprise LLC, doing business as Canna CabanaBus (Applicant), requesting that the Commission grant an additional 30 days to comply with the terms of Decision No. C23-0187 (Decision).

2. On January 30, 2023, Applicant filed an application for permanent authority to operate as a common carrier by motor vehicle for hire.

3. The Commission noticed the application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on February 6, 2023. This proceeding was uncontested; and thus, it was determined without a hearing.

4. On March 20, 2023, the Commission issued the Decision and granted the permanent authority, subject to Applicant's full compliance with the requirements contained in Ordering Paragraph No. 3 of the Decision.

5. Ordering Paragraph No. 3 of the Decision requires Applicant to file proof of insurance; pay the motor vehicle fee and issuance fee; submit an advice letter with tariff and vehicle inspection; and register with the Commission's electronic filing system.

6. The Decision gave Applicant 60 days from its effective date to comply with each of these requirements. For good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within 60 days of the effective date of the Decision.

7. On May 19, 2023, Applicant timely filed the instant request for "an additional 30 days to get the insurance submitted." Applicant explains the following:

I have met and uploaded, paid, or filed all Conditional Requirements requested for my Permanent Authority. However, for two weeks, my insurance company has had a variety of clerical errors and a multitude of people in a variety of departments involved. I personally have had contact with a variety of staff within the PUC in addition to the insurance companies to get clarifications on requirements and process for insurance verification. I hope to have the insurance uploaded by the insurance company by this day, May, 19, 2023. However, even with a rushed importance on the file, getting them to put it through the PUC e-file system has seemed to be an issue.

8. The Commission concludes that good cause exists to grant Applicant's request for an additional 30 days to comply with the Decision.

II. ORDER

A. The Commission Orders That:

1. The request submitted by AES Enterprise LLC, doing business as Canna CabanaBus, on May 19, 2023, that the Commission grant an additional 30 days to complete the requirements set forth in Decision No. C23-0187 is granted.

2. AES Enterprise LLC, doing business as Canna CabanaBus, is granted 30 days from the Mailed Date of this Decision to comply with the requirements set forth in Decision No. C23-0187.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective on its Mailed Date.
