**I. BY THE COMMISSION**

**A. Statement, Findings, and Conclusions**

1. By Decision No. C23-0376, issued June 6, 2023, the Commission solicited comments from the parties to this Proceeding relating to potential changes to the Timing Performance Incentive Mechanism (PIM) for segments 2 and 3 of the Colorado Power Pathway. Decision No. C23-0376 directs that any such comments be filed on or before June 20, 2023.

2. On June 9, 2023, Trial Staff of the Commission (Trial Staff) filed an Application for Rehearing, Reargument, or Reconsideration (RRR) of Decision No. C23-0376, requesting that Decision No. C23-0376 be modified to allow parties to file responsive comments. Trial Staff states that an opportunity for responsive comments will provide the Commission with a more robust record on which to evaluate potential changes to the Timing PIM. Trial Staff proposes that responsive comments be due on July 11, 2023.

3. We agree that allowing responsive comments is appropriate to create a more robust record regarding potential changes to the Timing PIM. Therefore, we grant Trial Staff's Application for RRR. Any responsive comments shall be filed on or before July 11, 2023.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The Application for Rehearing, Reargument, or Reconsideration of Decision No. C23-0376, filed on June 9, 2023, by Trial Staff of the Commission is granted, consistent with the discussion above.

2. The 20-day time period provided pursuant to § 40-6-116, C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the effective date of this Decision.

3. This Decision is effective on its Mailed Date.
