**I. BY THE COMMISSION**

**A. Statement, Findings, and Conclusions**

1. On March 31, 2020, Mountain Merchants LLC, doing business as Rocky Mountain Ride (Rocky Mountain Ride), filed an Application to Suspend Certificate of Public Convenience and Necessity (CPCN) PUC No. 55855, from March 31, 2020 through June 30, 2020, due to the COVID-19 pandemic.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on April 6, 2020, for a period of ten days. No petition to intervene or otherwise participate in this proceeding was filed. By Decision No. C20-0311, mailed on April 30, 2020 in this proceeding, the Commission granted the unopposed suspension of operations.

3. On June 8, 2020, Rocky Mountain Ride submitted a letter, requesting that CPCN PUC No. 55855 be reactivated. The letter states: “We would like to begin operating once again under (CPCN PUC No. 55855) on June 11th, 2020. We have purchased vehicle stamps for 2020 and the rates and fares named in the existing tariff will continue to be charged for the services

authorized by Certificate 55855.” Rocky Mountain Ride also has the required insurance on file with the Commission.

4. Therefore, the Commission finds good cause to construe this letter as a motion to lift the suspension of CPCN PUC No. 55855 and grant the motion.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The filing provided on June 8, 2020, by Mountain Merchants LLC, doing business as Rocky Mountain Ride, is construed as a motion requesting to lift the suspension of Certificate of Public Convenience and Necessity (CPCN) PUC No. 55855, and the motion is granted.

2. The suspension of CPCN PUC No. 55855 is lifted as of June 11, 2020, consistent with the discussion above.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective on its Mailed Date.
