SECOND REQUEST FOR AN EXTENSION OF TIME**

**I. BY THE COMMISSION**

**A. Statement, Findings, and Conclusions**

1. This matter comes before the Commission for consideration of a letter submitted on January 19, 2024, by Harris & Co. Holdings, LLC, doing business as GEST Carts Denver (Applicant)<sup>1</sup>, requesting that the Commission grant another extension of time (15-30 days) to comply with the terms of Decision No. C23-0600 (Decision).

2. On July 10, 2023, Applicant filed an application for new permanent authority to operate as a common carrier of passengers by motor vehicle for hire.

3. The Commission noticed the application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on July 17, 2023. This proceeding was uncontested; and thus, it was determined without a hearing.

4. On September 12, 2023, the Decision was issued, granting the application. In Ordering Paragraph No. 3, the Decision set forth certain requirements, such as filing proof of insurance that were to be completed within 60 days of the Decision's effective date. The Decision further states that for good cause shown, the Commission may grant additional time for compliance.

5. By Decision No. C23-0777, mailed on November 21, 2023, the Commission granted Applicant's first request for additional time and gave Applicant an additional 60 days to complete the requirements set forth in the Decision.

6. In this second request for additional time, Applicant explains, in part:

My family has been hit with a couple of deaths in the past two months and it has been hard. I also lost my stepbrother a couple of days before Christmas, and it has been difficult to process all of this loss.

We are requesting an extension due to a mix-up with the Insurance Agent. Unfortunately, we had to seek another agent due to ours being unresponsive. We have secured a new one and we are waiting for the final documents to be finalized.

7. The Commission concludes that good cause exists to extend the time for compliance with the requirements of the Decision for an additional 30 days.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The request submitted by Harris & Co. Holdings, LLC, doing business as GEST Carts Denver, on January 19, 2024, that the Commission grant another extension of time for it to complete the requirements set forth in Decision No. C23-0600, is granted.

2. Harris & Co. Holdings, LLC, doing business as GEST Carts Denver, is granted 30 days from the Mailed Date of this Decision to comply with the requirements set forth in Decision No. C23-0600.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective on its Mailed Date.
