I. BY THE COMMISSION

A. Statement, Findings, and Conclusions

1. On October 10, 2023, Rapid Creek Cycles & Sports LLC, doing business as Palisade Plunge Cycle and Shuttle, filed an application seeking approval to suspend operations under its authority, Certificate of Public Convenience and Necessity (CPCN) PUC No. 55955, for the winter season.

2. By Decision No. C23-0754, mailed on November 8, 2023, the Commission granted the unopposed application for a suspension of operations from October 10, 2023, through May 14, 2024.

3. On April 26 2024, Rapid Creek Cycles & Sports LLC, doing business as Palisade Plunge Cycle and Shuttle, submitted a letter, which stated the following: “Please make a motion to activate PUC# 55955 effective 4/26/24.”

4. The Commission finds good cause to grant this request and lift the suspension of operations under CPCN PUC No. 55955.

II. ORDER

A. The Commission Orders That:

1. The letter filed on April 26, 2024, by Rapid Creek Cycles & Sports LLC, doing business as Palisade Plunge Cycle and Shuttle, requesting that the Commission reactivate Certificate of Public Convenience and Necessity PUC No. 55955, is granted.

2. The suspension of operations granted by Decision No. C23-0754 is lifted.

3. Prior to commencing operations, Rapid Creek Cycles & Sports LLC, doing business as Palisade Plunge Cycle and Shuttle, shall: (a) cause proof of insurance or surety bond coverage to be filed with the Commission pursuant to Rule 6008, 4 *Code of Colorado Regulations* 723-6; (b) pay to the Commission the applicable vehicle identification fee for each vehicle to be operated under authority granted by the Commission; and, (c) ensure that an effective tariff is on file with the Commission, in compliance with applicable Commission rules

4. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

5. This Decision is effective on its Mailed Date.
