I. BY THE COMMISSION

A. Statement

1. On May 15, 2024, the Commission gave notice that the above-styled proceeding had been opened. On May 24, 2024, Decision No. C24-0353 (Decision) was sent to jurisdictional telecommunications carriers regarding the annual filing requirements for Commission certification of eligible telecommunications carriers (ETCs). The Decision allowed for the filing of reasonable extensions of time on or before August 15, 2024, the due date for support filings.

2. On August 22, 2024, a Motion for Extension of Time (“Motion”) to file its ETC Annual Report was filed by ALLO Communications, LLC (“ALLO”). The Motion requested an extension of time to August 30, 2024, for ALLO to file its 2024 ETC annual reports with the Commission.

3. As grounds for the extension of time, ALLO states that due to other pressing business needs and unforeseen circumstances, ALLO is unable to meet the filing deadline of

August 15, 2024. ALLO intends to submit its ETC Report by August 30, 2024. Therefore, ALLO requests a reasonable extension of time to submit its ETC Report.

4. This miscellaneous proceeding is not contested. Therefore, response time to the Motion will be waived pursuant to Rule 1400(b) of the Rules of Practice and Procedure, 4 *Code of Colorado Regulations* 723-1.

5. The Motion states good cause, and the requested extension of time to and including August 30, 2024, will be granted.

6. As of August 30, 2024, ALLO submitted its annual ETC reporting requirements as described in the Decision.

II. **ORDER**

A. **The Commission Orders That:**

1. The Motion for an Extension of Time in which to file Eligible Telecommunications Carrier annual report filed by ALLO Communications, LLC, is granted, *nunc pro tunc*, through August 30, 2024.

2. This Decision is effective immediately on its Issued Date.
