**I. BY THE COMMISSION**

**A. Statement, Findings, and Conclusions**

1. On May 3, 2024, Mara Ink filed an Application seeking approval to suspend operations under its authority, Certificate of Public Convenience and Necessity (“CPCN”) PUC No. 55960, from May 3, 2024 through October 18, 2024.

2. The Commission noticed this Application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on May 13, 2024, for a period of ten days.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter was determined without a hearing.

4. The application filed by Mara Ink for authority to suspend operations under Certificate of Public Convenience and Necessity (“CPCN”) PUC No. 55960 was granted, *nunc pro tunc*, from May 3, 2024, through October 18, 2024, by Decision C24-0408 on June 17, 2024.

5. On October 2, 2024, the manager of Mara Ink filed a request, titled a Motion, to extend the suspension period granted by Decision No. C24-0408.

6. To support the request to extend the suspension period, the manager of Mara Ink states:

We at Mara Ink had submitted and were awarded our request to pause our Authority our PUC # is 55960 {Mara Ink}. We respectfully ask that we extend the pause of our authority from October 18th, 2024, to November 15<sup>th</sup>, 2024. We are requesting this because we only operate during the winter ski season, and we do not have any reservations for October as none of the ski resorts are open and there is no public necessity at this time. It also helps us by not having to start operations prematurely and reestablish our commercial insurance policy because they ask for a massive down payment and we would like not to start prematurely if we don't have any work in October.

7. In consideration of the information provided by the manager of Mara Ink, the Commission finds good cause has been shown to extend the suspension period for CPCN PUC No. 55960 and to grant the request.

**II. ORDER**

**A. The Commission Orders That:**

1. The request filed by Mara Ink on October 2, 2024, to extend the suspension granted by Decision. No, C24-0408 for Certificate of Public Convenience and Necessity (“CPCN”) PUC No. 55960 through November 15, 2024, is granted.

2. On November 16, 2024, CPCN PUC No. 55960 shall be administratively reactivated.

3. Prior to commencing operations, Mara Ink shall: (a) cause proof of insurance or surety bond coverage to be filed with the Commission pursuant to Rule 6008, 4 *Code of Colorado Regulations* 723-6; (b) pay to the Commission the applicable vehicle identification fee for each

vehicle to be operated under authority granted by the Commission; and, (c) ensure that an effective tariff is on file with the Commission, in compliance with applicable Commission rules.

4. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

5. This Decision is effective on its Issued Date.
