**I. STATEMENT**

**A. Procedural Background**

1. On December 1, 2023, Tri-State Generation and Transmission Association, Inc. (Tri-State) filed an Application for Approval of its 2023 Electric Resource Plan (Application). The filing of the Application commenced this Proceeding.

2. By Decision No. R24-0080-I, issued February 6, 2024, the undersigned Administrative Law Judge (ALJ), among other things, granted Moffat County's and the City of Craig's, (together, Moffat/Craig) Motion to permissively intervene in this Proceeding.

3. On April 3, 2024, Moffat/Craig filed the Unopposed Motion of Moffat County and the City of Craig Requesting the Scheduling of a Public Comment Hearing (Motion Requesting Public Comment Hearing).

**B. Motion Requesting to Hold a Public Comment Hearing**

4. In the Motion Requesting Public Comment Hearing, Moffat/Craig “request the Commission schedule an in-person public comment hearing in Craig, Colorado, preferably at a date prior, and near in time, to the July evidentiary hearing.”<sup>1</sup> Moffat/Craig explain that they

believe that it is important for the Commission to hear from members of the public, especially those living in Moffat County, which anchors Craig Station, by providing the public with the opportunity to voice their opinions about the proposed accelerated closure of Craig Unit 3 and how it will affect the local community, coal workers, and the local economy.<sup>2</sup>

5. The Motion Requesting Public Comment Hearing is unopposed and states good cause for the requested relief, and will therefore be granted, as ordered below.

6. The undersigned ALJ has carefully considered Moffat/Craig’s request in the context of the agency’s full case schedule and limited staff availability. An in-person public comment hearing shall be held in Craig, Colorado on July 9, 2024, as ordered below.

7. Because the venue of the in-person public comment hearing session in Craig, Colorado has not yet been confirmed, the same will be identified by a subsequent interim decision in this Proceeding.

8. To allow members of the public who are unable to attend an in-person hearing in Craig to submit live comments, the ALJ will hold an additional virtual public comment session on July 11, 2024, as ordered below.

**1. Observing or Participating in the In-Person Public Comment Hearing**

9. The in-person public comment hearing will be held in Craig, Colorado, on Tuesday, July 9, 2024, at a location to be determined. The hearing will take place from 3:00 p.m. until not later than 6:00 p.m. The hearing will conclude upon the completion of the public

comments, but no earlier than 5:30 p.m. The venue and additional information about the hearing will be specified by a forthcoming decision.

10. Members of the public who wish to observe but not provide comments will be able to view the public comment hearing live and recorded on the Commission's YouTube channel at: <https://www.youtube.com/@COPublicUtilitiesCommission/>.

## **2. Observing or Participating in the Virtual Public Comment Hearing**

11. The virtual public comment hearing will be hosted using Zoom video-conferencing services. The hearing will take place from 4:00 p.m. until no later than 6:00 p.m. The hearing will conclude upon the completion of the public comments, but no earlier than 5:30 p.m.

12. Information about how to register to join the public comment hearing and to provide live comments will be specified by a forthcoming decision.
