I. BY THE COMMISSION

A. Statement, Findings, and Conclusions

1. This matter comes before the Commission for consideration of a motion submitted on December 19, 2024, by Comedy Crown LLC (“Applicant”), requesting that the Commission grant “one more” 30-day extension to comply with the terms of Decision No. C24-0533 (“Decision”).

2. On May 28, 2024, Applicant filed an Application for new permanent authority to operate as a common carrier of passengers by motor vehicle for hire.

3. The Commission noticed the application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on June 3, 2024. This proceeding was uncontested; and thus, it was determined without a hearing.

4. On July 25, 2024, the Commission issued the Decision and granted the application, subject to Applicant's full compliance with the requirements contained in Ordering Paragraph No. 3 of the Decision within 60 days of its effective date.

5. By Decision No. C24-0844, issued on November 19, 2024, the Commission granted Applicant's second request for a 30-day extension. Applicant was granted until December 19, 2024, to comply with the requirements set forth in the Decision.

6. On December 19, 2024, Applicant filed this third request for an extension of 30 days to comply with the Decision. Applicant states that more time is needed for the proof of insurance to be completed.

7. The Commission concludes that good cause exists to grant Applicant's request for one more extension of 30 days to comply with the Decision. This will be the final extension of time granted for Applicant to comply with all the requirements set forth in the Decision.

II. ORDER

A. The Commission Orders That:

1. The filing submitted by Comedy Crown LLC, on December 19, 2024, requesting that the Commission grant "one more" 30-day extension for it to complete the requirements set forth in Decision No. C24-0533, is granted.

2. Comedy Crown LLC is granted 30 days from the Issued Date of this Decision to comply with the requirements set forth in Decision No. C24-0533. No more additional time will be allowed.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an Application for Rehearing, Reargument, or Reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective immediately upon its Issued Date.
