**I. BY THE COMMISSION**

**A. Statement**

1. This matter comes before the Commission for consideration of a Motion for Extension of Time (“Motion”) filed by the Union Pacific Railroad Company (“UPRR”) on December 27, 2024, requesting an extension of time to December 31, 2026, to file updates to the National Inventory Forms with the Commission.

2. As grounds for the Motion, UPRR states that applicants City of Colorado Springs and El Paso County requested an extension of time to December 31, 2026, to complete the crossing construction project approved in the instant proceeding that was approved by the Commission by Decision No. C24-0748 issued October 21, 2024.

3. UPRR states in the Motion that it will be unable to update the National Inventory Forms for this application until the project is complete for which the Commission has approved an extension to December 31, 2026, to complete the project. UPRR requests an extension of time to the same date approved by the Commission, December 31, 2026, to file the updated National Inventory Forms in this proceeding.

4. No responses were filed to the Motion.
