I. BY THE COMMISSION

A. Statement, Findings, and Conclusions

1. This matter comes before the Commission for consideration of a letter submitted on December 30, 2024, by Wild West Excursions LLC, doing business as Wild West X (“Applicant”), requesting that the Commission grant a 30-day extension to comply with the terms of Decision No. C24-0772 (“Decision”).

2. On August 29, 2024, Applicant filed an application for permanent authority to extend operations under its Certificate of Public Convenience and Necessity PUC No. 56003.

3. The Commission noticed the application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on September 9, 2024. This proceeding was uncontested; and thus, it was determined without a hearing.

4. On October 24, 2024, the Commission issued the Decision and granted the application, subject to Applicant's full compliance with the requirements contained in Ordering Paragraph No. 3 of the Decision.

5. The Decision gave Applicant 60 days from its effective date of October 24, 2024, to comply with the Order; otherwise, “the requested extension of authority under CPCN PUC No. 56003 will be deemed denied.”

6. Therefore, Applicant had until December 23, 2024, to complete the terms of the Decision. Applicant did not comply with all the requirements; thus, the proceeding was closed without the extended authority being issued.

7. In the letter submitted on December 30, 2024, Ms. Cara Randolph, the agent for Applicant, requests a 30-day extension “due to unforeseen personal circumstances, involving our cattle operation, and for my ignorance in the procedural processes of the filing requirements...”

8. The Commission concludes that good cause exists to reopen the proceeding and grant Applicant's request for a 30-day extension to comply with the Decision.

II. ORDER

A. The Commission Orders That:

1. The filing submitted by Wild West Excursions LLC, doing business as Wild West X, on December 30, 2024, requesting that the Commission grant a 30-day extension for it to complete the requirements set forth in Decision No. C24-0772, is granted.

2. Wild West Excursions LLC, doing business as Wild West X, is granted 30 days from the Issued Date of this Decision to comply with the requirements set forth in Decision No. C24-0772.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an Application for Rehearing, Reargument, or Reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective immediately upon its Issued Date.
