I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

- 1. On May 1, 2025, BreckDirect LLC, doing business as Peak 1 Express and/or Peak One Express, filed an Application requesting that the Commission authorize the suspension of scheduled service operations under Certificate of Public Convenience and Necessity ("CPCN") PUC No. 55937, from May 1, 2025, through November 1, 2025.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on May 5, 2025, for a period of 10 days.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This Proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

¹ Item (I) of CPCN PUC No. 55937 authorizes the transportation of passengers in scheduled service between 100 Wulfson Road in Glenwood Springs, Colorado, and the Hanging Lake parking lot at Exit 125 of Interstate Highway 70, State of Colorado. It is restricted to service provided from May 1 through October 31 of each year.

- 4. In accordance with Rule 6205 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* ("CCR") 723-6, the information submitted with this Application warrants the granting of the requested partial suspension.
- 5. The application for authority to suspend the scheduled service portion (Item I) of CPCN PUC No. 55937 is not contrary to the public interest and will be granted.

II. ORDER

A. The Commission Orders That:

- 1. The Application is deemed complete, for purposes of § 40-6-109.5, C.R.S.
- 2. The application filed by BreckDirect LLC, doing business as Peak 1 Express and/or Peak One Express, for authority to suspend the scheduled service portion (Item I) of Certificate of Public Convenience and Necessity ("CPCN") PUC No. 55937 is granted, *nunc pro tunc*, from May 1, 2025, through November 1, 2025.
- 3. Prior to commencing scheduled services, BreckDirect LLC, doing business as Peak 1 Express and/or Peak One Express, shall ensure: (a) proof of insurance or surety bond coverage is filed with the Commission pursuant to Rule 6008, 4 *Code of Colorado Regulations* ("CCR") 723-6; (b) the applicable vehicle identification fee for each vehicle to be operated under authority granted by the Commission is paid; and, (c) an accurate and effective tariff and time schedule is on file with the Commission, in compliance with applicable Commission rules.
- 4. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an Application for Rehearing, Reargument, or Reconsideration shall begin on the first day after the Commission mails or serves this Decision.
