I. BY THE COMMISSION

A. Statement, Findings, and Conclusions

- 1. This matter comes before the Commission for consideration of a letter submitted on May 23, 2025, by Gregory Cobble, the Owner/Operator of E-Bike Tours & Rental, Manitou Springs, LLC ("Applicant"), requesting that the Commission grant additional time for the company to comply with the terms of Decision No. C25-0232 ("Decision").
- 2. On January 17, 2025, Applicant filed an Application for Permanent Authority to Operate as a Common Carrier of Passengers by Motor Vehicle for Hire.
- 3. The Commission noticed the Application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on February 3, 2025. This proceeding was uncontested; and thus, it was determined without a hearing.

- 4. On March 28, 2025, the Commission issued the Decision and granted the Application, subject to Applicant's full compliance with the requirements contained in Ordering Paragraph No. 3 of the Decision.
- 5. Ordering Paragraph No. 3 of the Decision requires Applicant to file proof of insurance; pay the motor vehicle fee and issuance fee; submit an Advice Letter with Tariff and vehicle inspections and register in the Commission's electronic filing system.
- 6. The Decision gave Applicant 60 days from its effective date, or until May 27, 2025, to comply with each of these requirements. For good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within 60 days of the effective date of the Decision.
- 7. On May 23, 2025, Applicant timely filed the instant request, stating that more time is needed to secure the insurance documents.
- 8. The Commission concludes that good cause exists to grant the Applicant an additional 60 days to comply with the Decision.

II. ORDER

A. The Commission Orders That:

- 1. The filing submitted by E-Bike Tours & Rental, Manitou Springs, LLC, on May 23, 2025, requesting that the Commission grant additional time for it to complete the requirements set forth in Decision No. C25-0232, is granted.
- 2. E-Bike Tours & Rental, Manitou Springs, LLC, is granted an additional 60 days from the Issued Date of this Decision to comply with the requirements set forth in Decision No. C25-0232.

- 3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an Application for Rehearing, Reargument, or Reconsideration shall begin on the first day after the Commission mails or serves this Decision.
 - 4. This Decision is effective immediately upon its Issued Date.
