I. BY THE COMMISSION

A. Statement

1. This matter comes before the Commission for consideration of approval of five Corrective Action Plans (“CAP”) that were submitted by the metro Denver area Regional Transportation District light rail operation that occurred between April 1, 2025, and June 30, 2025. A report summarizing the CAP was filed by the Staff of the Public Utilities Commission (“Staff”) on September 19, 2025.

2. The CAPs to be reviewed by the Commission are CAP01-05122025, CAP01-05312025, and CAP01-06082025, for final approval and monitoring to closure.

3. This matter also comes before the Commission for consideration of 15 CAPs that Staff has monitored and verified that all CAP elements have been completed as outlined in the CAPs and as discussed in the report summarizing the CAPs filed by Staff on September 19, 2025. The CAP numbers reviewed by the Commission for closure are CAP01-11112021, CAP02-07272022, CAP02-04242024, CAP08-04242024, CAP09-04242024, CAP10-04242024,

CAP11-04242024, CAP01-07242024, CAP01-08062024, CAP02-09262024, CAP01-11162024, CAP01-11252024, CAP01-01092025, CAP01-01142025, and CAP01-01252025.

4. The Commission has reviewed the summary report filed by Staff and concurs with Staff's review of the CAPs and recommendations for final approval and monitoring to closure of the three new CAPs, and for closure of the 15 existing open CAPs.

5. The Commission has jurisdiction in this matter under § 40-18-103, C.R.S., and Rule 7347 of the Rules Regulating Railroads, Rail Fixed Guideways, Transportation by Rail, and Rail Crossings, 4 *Code of Colorado Regulations* 723-7.

II. ORDER

A. The Commission Orders That:

1. The Commission provides final approval of and monitoring to closure of CAP01-05122025, CAP01-05312025, and CAP01-06082025 submitted by the metro Denver area Regional Transportation District light rail operations and closure of CAP01-11112021, CAP02-07272022, CAP02-04242024, CAP08-04242024, CAP09-04242024, CAP10-04242024, CAP11-04242024, CAP01-07242024, CAP01-08062024, CAP02-09262024, CAP01-11162024, CAP01-11252024, CAP01-01092025, CAP01-01142025, and CAP01-01252025.

2. This Decision is effective immediately upon its Issued Date.
