**COMMISSION DECISION GRANTING TIME SCHEDULE
CHANGES ON LESS-THAN-STATUTORY NOTICE**

I. BY THE COMMISSION

A. Statement

1. On October 29, 2025, Ramblin' Express, Inc. (Ramblin' Express), filed an application for authority to file the 6th Revised Page 12 and the 6th Revised Page 13 to Passenger Tariff, Colorado PUC No. 3¹ to become effective on less-than-statutory notice.

2. On October 31, 2025, Ramblin' Express filed a supplement to this Application requesting that the 3rd Revised Page 17 and the 3rd Revised Page 18 to Passenger Tariff, Colorado PUC No. 3 also become effective on less-than-statutory notice.

3. Ramblin' Express, under Certificate No. 47966, may provide scheduled service between points in Pueblo and Colorado Springs, on the one hand, and points in Cripple Creek, Colorado, on the other hand.

¹ Rule 6209(a), 4 *Code of Colorado Regulations* 723-6, Time Schedules, requires that a common carrier with scheduled authority file its time schedule as part of its common carrier tariff. Therefore, the schedules are a section of Ramblin' Express's Passenger Tariff, Colorado PUC No. 3.

4. Ramblin' Express is proposing to revise the frequency of the scheduled service authorized by Certificate No. 47966 by eliminating the one round-trip provided on Wednesday between 1615 S. Prairie Avenue, Pueblo and the casinos in Cripple Creek, and the four round trips provided Thursday through Sunday between 1615 S. Prairie Avenue, Pueblo and the casinos in Cripple Creek.

5. Ramblin' Express is also proposing to change the location of a scheduled stop in Colorado Springs from 555 S. 8th to 1050 21st Street.

6. To support the proposed revisions to the scheduled service, Todd Holland, the president of Ramblin' Express, provided the following statements:

After leasing our current pick-up location on the west side of Colorado Springs since 2008, we were recently given a short 30-day Notice to relocate, as the property is being redeveloped into apartments, etc. The demolition is scheduled to take place beginning on Monday, November 3rd. We have spent the last 4 weeks actively identifying and pursuing suitable locations, though found that process to be more difficult than expected. We have finally secured a suitable location and just finalized terms this morning. While we have informed our customers that changes will be coming, it is not until now that we are able to make the details public. The new location has ample bus access, parking, lighting, and security, and is less than 2 miles (5 minutes) from our current location, making the transition convenient for the public who use our scheduled services.

Along with the change in this location, we are also suspending the scheduled trips we have been running between Pueblo and Cripple Creek (which also runs between Pueblo and Colorado Springs) due to lack of demand.

7. As a common carrier, Ramblin' Express is required by Rule 6208(d) of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* ("CCR") 723-6 to file revised tariffs and time schedules on 30 days' notice. However, Rule 6208(d) 4 CCR 723-6, allows the Commission to approve an application for less than statutory notice to shorten the 30-day notice period.

8. In consideration of the support provided with this application, the Commission finds that Ramblin' Express has shown good cause to approve the proposed time schedule changes to Passenger Tariff, Colorado PUC No. 3 on the requested less than 30 days' notice.

II. ORDER

A. The Commission Orders That:

1. The Application filed on October 29, 2025, by Ramblin' Express, Inc. (Ramblin' Express) is deemed complete, for purposes of § 40-6-109.5, C.R.S.

2. The Application of Ramblin' Express to allow it to publish the 6th Revised Page 12, the 6th Revised Page 13, the 3rd Revised Page 17, and the 3rd Revised Page 18 to Passenger Tariff, Colorado PUC No. 3 to become effective on less-than-statutory notice is granted.

3. Ramblin' Express is authorized to file, on not less than one day's notice to the Commission, an advice letter and the 6th Revised Page 12, the 6th Revised Page 13, the 3rd Revised Page 17, and the 3rd Revised Page 18 to Passenger Tariff, Colorado PUC No. 3. The 6th Revised Page 12, the 6th Revised Page 13, the 3rd Revised Page 17, and the 3rd Revised Page 18 to Passenger Tariff, Colorado PUC No. 3 are attached as Appendix A and made a part of this Decision.

4. The advice letter and 6th Revised Page 12 and the 6th Revised Page 13, the 3rd Revised Page 17, and the 3rd Revised Page 18 to Passenger Tariff, Colorado PUC No. 3 shall be filed within ten days of the effective date of this Decision in a new Advice Letter Proceeding.

5. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the effective date of this Decision.

6. This Decision is effective upon its Issued Date.
